### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on [REDACTED] [REDACTED] from Detroit, Michigan. The Petitioner was represented by Petitioner and [REDACTED] the Petitioner's friend and neighbor. The Department of Health and Human Services (Department) was represented by [REDACTED], Hearings Facilitator.

### **ISSUE**

Did the Department properly reduce the Petitioner's Food Assistance Program (FAP) benefits?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED], the Department sent the Petitioner a Notice of Case Action informing the Petitioner that her FAP benefits were scheduled to be reduced.
2. On [REDACTED], Department sent Petitioner Notice of Case Action informing the Petitioner that her FAP benefits were to be reduced once again.
3. On [REDACTED], Petitioner requested a hearing to protest the reduction in her FAP benefits.

### CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, the Petitioner requested a hearing to protest the reduction of her FAP benefits. This reduction was caused by a number of factors. The Department had previously been listing the Petitioner's shelter as \$ [REDACTED] per month. This was reduced to \$ [REDACTED] per month in the Department's new budget.

In addition, there were two further reductions. On [REDACTED], a reduction occurred due to ongoing medical expenses being removed from the FAP budget; as a result, FAP decreased to \$ [REDACTED]. On [REDACTED], another FAP reduction occurred; and the FAP benefits decreased from [REDACTED] two \$ [REDACTED] per month. This second reduction was due to the standard deduction being reduced from \$ [REDACTED] to \$ [REDACTED] for the Petitioner's Excess Shelter Deduction.


After careful review, it appears to the undersigned ALJ that the Department correctly calculated the Petitioner's FAP benefits.

### DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it reduced the Petitioner's FAP benefits.

Accordingly, the Department's decision is **AFFIRMED**.
