# **HEARING DECISION FOR INTENTIONAL PROGRAM VIOLATION**

Upon the request for a hearing by the Department of Health and Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16 and 45 CFR 235.110; and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on October 20, 2016, from Lansing, Michigan. The Department was represented by #64, Regulation Agent of the Office of Inspector General (OIG). The Respondent was represented by herself.

#### **ISSUES**

- 1. Did Respondent receive an over issuance (OI) of FAP benefits that the Department is entitled to recoup?
- 2. Did the Department establish, by clear and convincing evidence, that Respondent committed an Intentional Program Violation (IPV)?
- 3. Should Respondent be disqualified from receiving benefits for 1 year?

#### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

 The Department's OIG filed a hearing request on January 26, 2016, to establish an OI of benefits received by Respondent as a result of Respondent having allegedly committed an IPV.

- 2. The OIG has requested that Respondent be disqualified from receiving program benefits.
- 3. Respondent was a recipient of FAP benefits issued by the Department. Department Exhibit 1, pgs. 66-71.
- 4. On the Assistance Application, DHS 1171 for MA, signed by Respondent on July 18, 2012, the Respondent reported that she understood the responsibility to report changes in household income to the department within 10 days. Department Exhibit 1, pgs. 10-30.
- 5. Respondent was aware of the responsibility to report changes in household income of her son's earned income from employment at starting on April 9, 2012 through November 30, 2013. Department Exhibit 1, pgs. 72-81.
- 6. Respondent had no apparent physical or mental impairment that would limit the understanding or ability to fulfill this requirement.
- 7. The Department's OIG indicates that the time period it is considering the fraud period is June 1, 2012 through November 30, 2013 (fraud period).
- 8. During the fraud period, Respondent was issued \$ in benefits by the State of Michigan, and the Department alleges that Respondent was entitled to \$ in such benefits during this time period.
- 9. The Department alleges that Respondent received an OI in FAP benefits in the amount of \$ \_\_\_\_\_\_\_
- 10. This was Respondent's first alleged IPV.
- 11. A notice of hearing was mailed to Respondent at the last known address and was returned by the US Post Office as undeliverable.

# **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT). Prior to August 1, 2008, Department policies were contained in the Department of Human Services Program Administrative Manuals (PAM), Department of Human Services Program Eligibility Manual (PEM), and Department of Human Services Reference Schedules Manual (RFS).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is

implemented by the federal regulations contained in 7 CFR 271.1 to 285.5. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10 and Mich Admin Code, R 400.3001 to .3015.

The Department's OIG requests IPV hearings for the following cases:

- FAP trafficking Ols that are not forwarded to the prosecutor,
- prosecution of welfare fraud or FAP trafficking is declined by the prosecutor for a reason other than lack of evidence, and
  - the total OI amount for the FIP, SDA, CDC, MA and FAP programs is \$1000 or more, or
  - the total OI amount is less than \$1000, and
    - > the group has a previous IPV, or
    - > the alleged IPV involves FAP trafficking, or
    - ➤ the alleged fraud involves concurrent receipt of assistance (see BEM 222), or
    - the alleged fraud is committed by a state/government employee.

BAM 720, p. 10.

## **Intentional Program Violation**

Suspected IPV means an OI exists for which all three of the following conditions exist:

- The client intentionally failed to report information or intentionally gave incomplete or inaccurate information needed to make a correct benefit determination, and
- The client was clearly and correctly instructed regarding his or her reporting responsibilities, and
- The client has no apparent physical or mental impairment that limits his or her understanding or ability to fulfill reporting responsibilities.

BAM 700, p. 6; BAM 720, p. 1.

An IPV is also suspected for a client who is alleged to have trafficked FAP benefits. BAM 720, p. 1.

An IPV requires that the Department establish by clear and convincing evidence that the client has intentionally withheld or misrepresented information for the **purpose** of

establishing, maintaining, increasing or preventing reduction of program benefits or eligibility. BAM 720, p. 1 (emphasis in original); see also 7 CFR 273(e)(6). Clear and convincing evidence is evidence sufficient to result in a clear and firm belief that the proposition is true. See M Civ JI 8.01.

# **Disqualification**

A court or hearing decision that finds a client committed IPV disqualifies that client from receiving program benefits. BAM 720, p. 12. A disqualified recipient remains a member of an active group as long as he lives with them, and other eligible group members may continue to receive benefits. BAM 720, p. 13.

Clients who commit an IPV are disqualified for a standard disqualification period except when a court orders a different period, or except when the OI relates to MA. BAM 720, p. 13. Refusal to repay will not cause denial of current or future MA if the client is otherwise eligible. BAM 710, p. 2. Clients are disqualified for periods of one year for the first IPV, two years for the second IPV, lifetime disqualification for the third IPV, and ten years for a FAP concurrent receipt of benefits. BAM 720, p. 16.

# **Overissuance**

When a client group receives more benefits than they are entitled to receive, the Department must attempt to recoup the OI. BAM 700, p. 1.

In this case, Respondent was a recipient of FAP benefits issued by the Department. Department Exhibit 1, pgs. 66-71. On the Assistance Application, DHS 1171 for MA, signed by Respondent on July 18, 2012, the Respondent reported that she understood the responsibility to report changes in household income to the department within 10 days. Department Exhibit 1, pgs. 10-30. Respondent was aware of the responsibility to report changes in household income of her son's earned income from employment at starting on April 9, 2012 through November 30, 2013. Department Exhibit 1, pgs. 72-81. Respondent had no apparent physical or mental impairment that would limit the understanding or ability to fulfill this requirement.

The Department's OIG indicates that the time period it is considering the fraud period is June 1, 2012 through November 30, 2013 (fraud period). During the fraud period, Respondent was issued in benefits by the State of Michigan, and the Department alleges that Respondent was entitled to in such benefits during this time period. The Department alleges that Respondent received an OI in FAP benefits in the amount of This was Respondent's first alleged IPV. A notice of hearing was mailed to Respondent at the last known address and was returned by the US Post Office as undeliverable.

During the hearing, the Respondent stated that she reported that her son was working to the Department Caseworker. The Department only submitted an application for MA submitted by the Respondent signed on July 18, 2012. There were no 6 month semi-annual reviews for FAP submitted by the Department. Because the Respondent's son's earned income was not counted, the Respondent received an overissuance of FAP

benefits during the contested time period. As a result, the Respondent received an over issuance of FAP benefits that the Department is required to recoup due to Department's error. The Department will have to redetermine the overissuance for the contested time period due to the Department's error where the Respondent is eligible for the 20% earned income deduction.

## **DECISION AND ORDER**

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, concludes that:

- 1. The Department **has not** established by clear and convincing evidence that Respondent committed an IPV.
- 2. Respondent **did** receive an OI of program benefits from the following program(s) FAP due to Department's error where the Respondent is eligible for the 20% earned income deduction.

The Department is ORDERED to initiate recoupment/collection procedures in accordance with Department policy.
