# HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on November 3, 2016, from Lansing, Michigan. The Petitioner was represented by himself. The Department of Health and Human Services (Department) was represented by Hearing Facilitator. Department Exhibit 1, pp.1-14 was received and admitted.

### **ISSUE**

Did the Department properly determine Petitioner's Food Assistance Program (FAP) benefits and Medical Assistance (MA) benefits?

## FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On September 29, 2016, the Department issued a Notice of Case Action explaining that there would be no increase in his FAP benefits and his FAP benefit would remain **\$** per month.
- 2. On October 3, 2016, the Department issued a Health Care Coverage Determination Notice stating that Petitioner was approved for MA benefits.
- 3. On October 5, 2016, Petitioner requested hearing contesting the determination of his FAP and MA benefits.

4. Petitioner stated at hearing that he was satisfied with the Department action related to his MA benefits.

# CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

## Heat Included

### in Rent or

## Fees

FAP groups whose heat is **included** in their rent or fees are not eligible for the h/u standard, **unless** they are billed for **excess heat** payments from their landlord. BEM 554

In this case, Petitioner receives \$ per month in gross income from his pension. Petitioner has rental obligation of \$ per month and is not responsible for heat and utilities. After subtracting the \$ standard deduction and the excess shelter deduction, Petitioner has net income of \$ per month. An individual with \$ per month net income is entitled to \$ in FAP benefits. RFT 260. This was the amount determined by the Department and it was proper and correct. BEM 556.

Petitioner questioned why he did not receive the heat and utility standard since he pays heat and utilities indirectly by paying rent. Department policy is clear that only individuals who are responsible for heat and utilities are entitled to receive the heat and utility standard. BEM 554


