ORDER OF DISMISSAL FOR LACK OF JURISDICTION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37, and 7 CFR 273.15 to 273.18, 42 CFR 431.200 to 431.250, 45 CFR 99.1 to 99.33, and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on from Detroit, Michigan. The Petitioner was represented by (Petitioner); and his Authorized Hearing Representative (AHR), The Department of Health and Human Services (Department) was represented by Hearings Facilitator.

Regulations governing the hearing and appeal process for applicants and recipients of public assistance in Michigan are found in Mich Admin Code, R 792.10101 to R 792.10137 and R 792.11001 to R 792.11020. Rule 792.11002(1) provides as follows:

An opportunity for a hearing shall be granted to an applicant who requests a hearing because his or her claim for assistance is denied or is not acted upon with reasonable promptness, has received notice of a suspension or reduction in benefits, or exclusion from a service program, or has experienced a failure of the agency to take into account the recipient's choice of service.

A client's request for hearing must be in writing and signed by an adult member of the eligible group, adult child, or authorized hearing representative (AHR). Department of Health and Human Services Bridges Administrative Manual (BAM) 600 (October 2015), p. 2. Moreover, BAM 600, p. 6 provides that a request for hearing must be received in the Department local office within 90 days of the date of the written notice of case action.

In the present case, the Department sent Petitioner a Health Care Coverage Determination Notice (determination notice) advising Petitioner of its decision to close his Medical Assistance (MA) and Medicare Savings Program (MSP) benefits effective . Exhibit A, pp. 8-11.

The Department's determination notice to Petitioner was dated Exhibit A, p. 8. However, Petitioner and his AHR did not file a request for hearing to contest the Department's action until Exhibit A, pp. 2-3.

Petitioner's hearing request was not timely filed within ninety days of the determination notice and is, therefore, **DISMISSED** for lack of jurisdiction. BAM 600, pp. 1-6.
