HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on November 23, 2016, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Hearing Facilitator. Department Exhibit 1, pp.1-26 was received and admitted.

<u>ISSUE</u>

Did the Department properly determine Petitioner's State Emergency Relief (SER) benefit and Family Independence Program (FIP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On October 17, 2016, Notice of Case Action was sent to Petitioner informing her that her FIP benefits would close for failure to return redetermination paperwork.
- 2. The Department reinstated FIP and Petitioner acknowledged this at hearing and agreed to dismiss her appeal regarding the FIP program.
- 3. Petitioner was approved an SER for rental assistance and was required to make a co-pay towards the rental deposit.

- 4. Petitioner paid her co-pay towards the security deposit. Petitioner provided proof of the co-pay at hearing and the Department was satisfied.
- 5. The Department failed to make the SER payment towards Petitioner's rental obligation.
- 6. Petitioner requested hearing on October 21, 2016, contesting the closure of her FIP benefits and protesting the Department's failure to pay their portion of her rent pursuant to her SER award.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Pub. L. No. 104-193, and 42 USC 601 to 679c. The Department (formerly known as the Department of Human Services) administers FIP pursuant to 45 CFR 233-260, MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3101-.3131.

The State Emergency Relief (SER) program is established by the Social Welfare Act, MCL 400.1-.119b. The SER program is administered by the Department (formerly known as the Department of Human Services) pursuant to MCL 400.10 and Mich Admin Code, R 400.7001-.7049.

Client Contribution

The SER group must contribute toward the cost of resolving the emergency if SER does not cover the full cost of the service. Other persons or organizations can also contribute funds on behalf of the SER group. Verification that the contribution has been paid must be received before any SER payment can be made. ERM 208 (October 2015)

In this case, Petitioner testified that she was satisfied with the reinstatement of her FIP benefits.

With regard to SER benefits, the Department acknowledged that Petitioner provided proof of her co-payment towards the rental security deposit and the Petitioner is entitled to payment towards her rental obligation. ERM 208

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it reinstated Petitioner's FIP benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with Department policy when it failed to pay the SER benefit of towards Petitioner's rental obligation.

Accordingly, the Department's decision is **AFFIRMED IN PART** with respect to FIP and **REVERSED IN PART** with respect to SER.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Award Petitioner SER benefits of towards her rental obligation.
