**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on November 28, 2016, from Detroit, Michigan. The Petitioner was present and represented by [REDACTED], Authorized Hearing Representative (AHR). The Department of Health and Human Services (Department) was represented by [REDACTED], Hearing Facilitator.

**ISSUE**

Did the Department properly close Petitioner's FAP benefits effective [REDACTED]

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a recipient of FAP benefits.
2. On or about [REDACTED], Petitioner's assigned worker received information indicating that Petitioner had been convicted of two or more drug related felonies which occurred after August 22, 1996.
3. On [REDACTED], the Department sent Petitioner a Notice of Case Action which notified Petitioner that his FAP benefits would close effective [REDACTED]

4. On [REDACTED], Petitioner's AHR filed a Request for Hearing disputing the Department's actions.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-119b, and Mich Admin Code, R 400.3001-.3011.

Additionally, an individual convicted of a felony for the use, possession, or distribution of controlled substances two or more times in separate periods will be permanently disqualified if both offenses occurred after August 22, 1996. BEM 203 (October 2015), p. 2. In this case, the Department testified that it received information that Petitioner had been convicted of two or more drug related felonies since August 22, 1996. As such, it sent notice to Petitioner advising that his FAP benefits would close effective [REDACTED].


Petitioner confirmed that he had been convicted of a drug-related felony on [REDACTED], [REDACTED] and [REDACTED]. Petitioner's AHR testified that she completed the April 2015 application for FAP benefits and that she indicated the Petitioner had not been convicted of a drug-related felony because she was unaware of the convictions. Petitioner testified that he has been under someone else's care since approximately 2007. Petitioner further testified that each time an application was submitted to the Department, his caregiver completed the application. Petitioner was never asked by any of his caregivers if he had been convicted of a drug related felony. Given that Petitioner confirmed that he has been convicted of at least two drug-related felonies since August 22, 1996, he is not eligible for FAP benefits.

**DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's FAP benefits effective [REDACTED].

Accordingly, the Department's decision is **AFFIRMED**.
