### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on December 5, 2016, from Detroit, Michigan. The Petitioner was represented by Petitioner. Served as an served as an Interpreter for the hearing. The Department of Health and Human Services (Department) was represented by Hearing Facilitator.

#### **ISSUE**

Did the Department properly decrease Petitioner's FAP benefits to **\$** per month effective ?

## FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner is an ongoing FAP recipient.
- 2. On period of Case Action which notified Petitioner that her FAP benefits would decrease to **\$** per month.
- 3. On performance, Petitioner filed a Request for Hearing disputing the Department's actions.

### CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Department testified that prior to redetermining Petitioner's eligibility for FAP benefits, it believed that Petitioner's rent expense was **Sector** per month. The Department received information that Petitioner's actual rent expense is **Sector** Petitioner confirmed that she pays a rent expense of **Sector** per month. Petitioner does not pay a heat expense, but does pay an electric expense.

Petitioner and her husband each receive **\$** in RSDI income and each receive **\$** per quarter in SSP which the Department testified that it budgets at **\$** per month. Petitioner does not pay a mortgage but during the previous years, she paid **\$** in taxes. The Department divided this amount by 12 for a monthly shelter expense of **\$** .

The Department presented a FAP net income budget in support of its position that it properly reduced Petitioner's FAP benefits. Based on Claimant's circumstances, she was eligible to receive a standard deduction of based on her two-person group size. RFT 255, p. 1. (October 2016). Petitioner was also eligible for a shelter deduction in the amount of \$100000. BEM 556, pp. 4-5. (July 2013). When the standard deduction and the shelter deduction are subtracted from Petitioner's income, her net income amount is \$100000.

On sector of the Department sent Petitioner a Notice of Case Action which notified her that her FAP benefits would decrease to **sector** monthly effective . Based on the information available to the Department, and based upon a net income of **sector**, it properly determined that Petitioner was entitled to a FAP benefit amount of **sector** per month. RFT 260 (October 2016), p. 10.

## DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in

accordance with Department policy when it decreased Petitioner's FAP benefits to \$ month effective the second sec

Accordingly, the Department's decision is **AFFIRMED**.
