**ORDER OF DISMISSAL PURSUANT TO  
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Administrative Hearing System upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing was commenced on [REDACTED], [REDACTED] from Detroit, Michigan. The Petitioner was represented by [REDACTED], the Petitioner's Authorized Hearing Representative (AHR) and Guardian. The Petitioner did not appear. The Department of Health and Human Services (Department) was represented by [REDACTED], Assistance Payments Supervisor.

The hearing was requested to dispute the Department's action taken with respect to the closure of the Petitioner's Medical Assistance application program benefits. Shortly after commencement of the hearing, Petitioner's AHR testified that she now understood the actions taken by the Department and had already signed a Hearing Withdrawal (which was not received by MAHS prior to the hearing), and did not wish to proceed with the hearing. The Request for Hearing was withdrawn. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
