HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on May 18, 2016, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by [REDACTED], Assistance Payments Supervisor and [REDACTED], Assistance Payments Worker.

ISSUE

Due to a failure to comply with the verification requirements, did the Department properly close the Petitioner's cases for Medical Assistance (MA), Food Assistance Program (FAP), and Child Development and Care (CDC)?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, including testimony of witnesses, finds as material fact:

1. The Petitioner applied for MA, FAP, and CDC benefits on March 23, 2016.
2. On March 24, 2016, the Department sent the Petitioner a Verification Checklist, DHS 3503 that was due April 4, 2016. Department Exhibit 4-8.
3. On April 7, 2016, the Department sent the Petitioner a notice that her application was denied because she failed to submit the required verifications. Department Exhibit 21-25.

4. On April 13, 2016, the Petitioner filed a hearing request, protesting the Department's action.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

The Child Development and Care (CDC) program is established by Titles IVA, IVE and XX of the Social Security Act, 42 USC 601-619, 670-679c, and 1397-1397m-5; the Child Care and Development Block Grant of 1990, PL 101-508, 42 USC 9858 to 9858q; and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, PL 104-193. The program is implemented by 45 CFR 98.1-99.33. The Department administers the program pursuant to MCL 400.10 and provides services to adults and children pursuant to MCL 400.14(1) and Mich Admin Code, R 400.5001-.5020.


In this case, the Petitioner applied for MA, FAP, and CDC benefits on March 23, 2016. On March 24, 2016, the Department sent the Petitioner a Verification Checklist, DHS 3503 that was due April 4, 2016. Department Exhibit 4-8. On April 7, 2016, the Department sent the Petitioner a notice that her application was denied because she failed to submit the required verifications. Department Exhibit 21-25. On April 13, 2016, the Petitioner filed a hearing request, protesting the Department's action. BAM 105, 115, 130, 200, 210, and 220. BEM 400, 702, and 704.

During the hearing, the Department stated that the Petitioner had only submitted 2 paystubs not 4, since she gets paid every week. During the hearing, the Petitioner was able to provide the required additional 2 paystubs. She will need to reapply for benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied the Petitioner's application for FAP, MA, and CDC because she failed to submit the required verification of 2 additional paystubs.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
