HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on June 15, 2016, from Lansing, Michigan. The Petitioner appeared on his own behalf. The Department of Health and Human Services (Department) was represented by Hearings Facilitator [REDACTED].

ISSUE

Did the Department properly close Petitioner's Food Assistance Program (FAP) and Medical Assistance (MA) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an on-going FAP and MA recipient.
2. On February 9, 2016, the Agency mailed a Redetermination (Exhibit 1 Pages 2-7) that Petitioner completed and returned.
3. Petitioner stated in the Redetermination that he had a debit card, and on March 21, 2016, the Agency mailed a Verification Checklist (Page 8-9) (VCL) requiring Petitioner to provide proof of the balance in the account by March 31, 2016.

4. Petitioner did not provide the verification, or ask the Department for help in obtaining the verification, by the deadline.
5. On April 14, 2016, the Agency mailed a Notice of Case Action (Pages 10-13) closing Petitioner's FAP, and according to the Department's witness and Petitioner, it also closed his MA.
6. On May 5, 2016, the Department received Petitioner's hearing request, challenging the decision to close his FAP and MA.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Per BAM 130 (10/1/14), at page 6:

Verifications are considered to be timely if received by the date they are due. For electronically transmitted verifications (fax, email or Mi Bridges document upload), the date of the transmission is the receipt date. Verifications that are submitted after the close of regular business hours through the drop box or by delivery of a DHS representative are considered to be received the next business day.

Send a negative action notice when:

The client indicates refusal to provide a verification, **or**

The time period given has elapsed and the client has **not** made a reasonable effort to provide it.

The evidence is persuasive that the documentation requested by the Department was not received by the due date. Consequently, the Department was to send a negative action notice.


In this case, Petitioner was obligated by policy to respond to the VCL. He testified that he tried to get a document from Comerica to show the balance in his account, but it took two months and by the time it arrived he was past the deadline. He did not ask the Department for help. He did not contact the Department to let them know he was having trouble getting the document. Once the deadline passed, the Department had to close his benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's FAP and MA.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
