HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on August 1, 2016, from Detroit, Michigan. The Petitioner was represented by Petitioner. [REDACTED] [REDACTED] appeared with Petitioner as an observer. The Department of Health and Human Services (Department) was represented by [REDACTED], Hearing Facilitator.

ISSUE

Did the Department properly deny Petitioner's application for MA benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner applied for MA benefits on [REDACTED].
2. On [REDACTED], the Department sent Petitioner a Health Care Coverage Determination Notice which informed Petitioner that his application had been denied due to exceeding the income limit.
3. On [REDACTED], Petitioner filed a Request for Hearing disputing the Department's actions.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Additionally, HMP provides MA coverage to individuals who (i) are 19 to 64 years of age; (ii) have income at or below 133% of the federal poverty level (FPL) under the Modified Adjusted Gross Income (MAGI) methodology; (iii) do not qualify for or are not enrolled in Medicare; (iv) do not qualify for or are not enrolled in other MA programs; (v) are not pregnant at the time of application; and (vi) are residents of the State of Michigan. MPM, Healthy Michigan Plan, § 1.1.

On [REDACTED], Petitioner applied for MA benefits. The Department did not assert that Petitioner was qualified for or enrolled in any other MA programs. On [REDACTED], the Department testified that it sent Petitioner a Health Care Coverage Determination Notice because his income exceeded the [REDACTED] income limit for a group size of one under the Health Michigan Plan.

The Department determined that Petitioner's monthly income was [REDACTED], which equals a yearly income of [REDACTED]. However, the Department was unable to explain how it arrived at this income amount. Initially, the Department testified that it used the information Petitioner reported in his application which was [REDACTED] weekly. The Department later testified that its computer used the income reported to a federal agency. Because the amount reported by Petitioner was less than the income limit and because the Department was unable to articulate the income amounts used in arriving at [REDACTED], it is found that it failed to establish that Petitioner exceeded the income limit for eligibility under the Healthy Michigan Plan.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with Department policy when it denied Petitioner's [REDACTED] application.


DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reregister and reprocess Petitioner's [REDACTED] application;
2. Issue any supplements Petitioner was eligible to receive but did not based upon the [REDACTED] application; and
3. Notify Petitioner in writing of its decision.
