HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on [REDACTED], from Detroit, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by [REDACTED], Assistance Payments Worker.

ISSUE

Did the Department properly deny the Petitioner's [REDACTED], State Emergency Relief (SER) application due to the emergency being resolved by payment of rent in full?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. The Petitioner applied for SER due to rent arrears and judgments of eviction on two occasions.
2. The Department issued an SER decision notice dated [REDACTED], which required the Petitioner to co-pay \$ [REDACTED] of the judgement; and the Department would pay \$ [REDACTED]
3. The Department issued a second Benefit Notice Decision on [REDACTED]. In that Decision Notice, the Department denied the Petitioner's second SER

application filed on [REDACTED], requesting assistance with payment of \$ [REDACTED] back rent.

4. The Department denied the [REDACTED], application because the Petitioner provided the Department a receipt with the application which indicated that the Petitioner, with assistance from her church, had paid in full the back rent amount of \$ [REDACTED]. The receipt was provided to the Department on [REDACTED].
5. The Petitioner requested a timely hearing on [REDACTED], protesting the Department's actions.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State Emergency Relief (SER) program is established by the Social Welfare Act, MCL 400.1-.119b. The SER program is administered by the Department (formerly known as the Department of Human Services) pursuant to MCL 400.10 and Mich Admin Code, R 400.7001-.7049.

State Emergency Relief (SER) prevents serious harm to individuals and families. SER assists applicants with safe, decent, affordable housing and other essential needs when an emergency situation arises. ERM (March 1, 2013), p. 1.

State Emergency Relief (SER) assists individuals and families to resolve or prevent homelessness by providing money for rent, security deposits, and moving expenses. ERM 303 (October 1, 2015) p. 6.

Requirements

Residence in the state of Michigan is not required. SER serves all persons physically present in Michigan. In addition SER applicants must:

- Complete the application process.
- Meet financial and non-financial requirements.
- **Have an emergency which threatens health or safety and can be resolved through issuance of SER.**

- Take action within their ability to help themselves. For example, obtain potential resources and/or apply for assistance.
- Not have caused the emergency; see ERM 204, Client-Caused Emergencies.
- Cooperate in providing information about income, assets, living arrangements, and other persons living in the home.

Deny SER services for applicants who fail to meet any of the above requirements. ERM 101, p. 1. (Emphasis supplied).

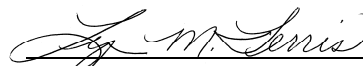
In this case, the Petitioner qualified for relocation services due to her eviction notice and judgment of eviction. Once the eviction was resolved by the payment of the rent arrearage by the Petitioner, the Petitioner could no longer be assisted by the Department as the original application amount requested to resolve the emergency had been paid in full by the Petitioner; and thus, the emergency had been resolved.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied the Petitioner's [REDACTED], application for SER rent assistance.

Accordingly, the Department's decision is **AFFIRMED**.
