### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on September 13, 2016, from Lansing, Michigan. Petitioner appeared and testified. The Department was represented by Assistance Payments Supervisor [REDACTED] and Assistance Payments Worker [REDACTED]. Testimony was received from all participants. Department's Exhibit A, pages 1-18 was admitted into evidence.

### **ISSUE**

Did the Department properly determine Petitioner's Medicare Cost Share eligibility on August 4, 2016?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On August 4, 2016, Petitioner applied for Medicare Cost Share benefits. Petitioner receives \$ [REDACTED] in Retirement Survivor Disability Income benefits each month.
2. On August 4, 2016, Petitioner was sent a Health Care Coverage Determination Notice (DHHS-1606) which stated he was not eligible for Medicare Cost Share benefits.
3. On August 12, 2016, Petitioner submitted a hearing request.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.


During this hearing Petitioner's financial eligibility budget was reviewed. Petitioner's income and allowed reported expenses were verified. in accordance with Bridges Eligibility Manual (BEM) 165 Medicare Savings Programs, Petitioner is not eligible for any of the three Medicare Savings Programs.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's Medicare Cost Share eligibility on August 4, 2016.

### **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.
