**ORDER OF DISMISSAL PURSUANT TO STIPULATION  
TO RECONSIDER ISSUES AND WITHDRAW HEARING REQUEST**

This matter is before the Michigan Administrative Hearing System upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing was to commence on [REDACTED], from Detroit, Michigan. The Petitioner was represented by Attorney, [REDACTED]. The Department of Health and Human Services (Department) was represented by [REDACTED], Assistant Attorney General.

The hearing was requested to dispute the Department's action taken with respect to the denial of Medical Assistance program benefits due to excess assets. Pursuant to a Stipulation to Reconsider Issues and Withdraw Hearing Request dated [REDACTED] the parties, through their respective attorneys, have agreed to the dismissal of this matter as follows: Attorney for Petitioner has agreed to withdraw the Hearing Request dated [REDACTED], reserving Petitioner's rights to challenge any future determination of benefits; Attorney for the Department has agreed that the Department will review Petitioner's case and determine Petitioner's eligibility and calculate the benefits if any, to which Petitioner is entitled.

Pursuant to the withdrawal of the hearing request by Stipulation to Reconsider Issues and Withdraw Hearing Request, dated [REDACTED], filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
