### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on September 28, 2016, from Detroit, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by [REDACTED], Hearings Facilitator.

### **ISSUE**

Did the Department properly apply a sanction to Petitioner's Food Assistance Program (FAP) benefit case for failing to comply with the Office of Child Support?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a FAP recipient.
2. A sanction was applied to Petitioner's FAP benefit case in March 2016 for noncooperation; this sanction was removed and reapplied several times.
3. No evidence was submitted regarding the validity of this sanction.
4. On August 26, 2016, Petitioner requested a hearing.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

While Petitioner originally requested a hearing with regard to Family Independence Program (FIP) benefits as well, Petitioner stated at hearing that there was no further grievance with that program. As such, Petitioner's request for hearing regarding FIP is dismissed.

The Department testified that Petitioner's FAP benefits had been reduced due to a child support noncooperation sanction back to March, 2016. Submitted documents indicate that this was the case, and the Department conceded that Petitioner had requested a hearing with regard to said sanction. However, no evidence was submitted supporting the validity of that sanction, nor was testimony offered to support the sanction.

As such, because no relevant evidence was submitted, the undersigned holds that the sanction in question was improperly applied.

### **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it decreased Petitioner's FAP benefits and applied a noncooperation sanction.


Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Remove any noncooperation sanctions currently in effect regarding Petitioner's benefit case, retroactive to March, 2016.

2. Recalculate Petitioner's FAP benefits retroactive to March, 2016.
