### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on October 13, 2016, from Lansing, Michigan. The Petitioner appeared on her own behalf. The Department of Health and Human Services (Department) was represented by General Services Program Manager [REDACTED].

### **ISSUE**

Did the Department properly determine Petitioner's Food Assistance Program (FAP) benefits?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an on-going FAP recipient who, based upon a group size of one with no income, was receiving \$ [REDACTED] per month in FAP.
2. Petitioner moved into a home with four other people, and the members of the household purchased and prepared food together.
3. The household has \$ [REDACTED] per month in income that was included in the FAP budget.

4. The Department mailed a Notice of Case Action (Exhibit 1 Pages 5-8) that informed Petitioner her FAP was being reduced to \$ [REDACTED] per month beginning October 1, 2016.
5. On September 6, 2016, the Department received Petitioner's hearing request, protesting the reduction in her FAP.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, Petitioner had been living alone, and her FAP was based upon her allowable income and expenses at that time. She moved into a home with four other people, and they all purchased and prepared food together. As explained in BEM 212 (10/1/15) p. 6, "In general, persons who live together and purchase and prepare food together are members of the FAP group."


The budget used by the Department in determining Petitioner's FAP (Page 9) shows that the Department counted the group's income, gave the group the earned income deduction and the standard deduction. The available evidence supports the finding that the new FAP group was eligible to receive \$ [REDACTED] per month in FAP.

**DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it reduced Petitioner's FAP.

Accordingly, the Department's decision is **AFFIRMED**.
