### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on [REDACTED], from Detroit, Michigan. The Petitioner was represented by [REDACTED] and her spouse, [REDACTED]. The Department of Health and Human Services (Department) was represented by [REDACTED], Hearings Facilitator.

### **ISSUE**

Did the Department properly calculate the Petitioner's Medical Assistance (MA) benefits?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. The Petitioner requested a hearing on [REDACTED], to protest the Department's MA calculations.
2. On [REDACTED], Department sent the Petitioner a Redetermination form with responses due [REDACTED].
3. On [REDACTED], the Department sent the Petitioner's bank a verification of assets form.

4. On [REDACTED], the Department sent the Petitioner a Health Care Coverage Determination Notice showing full coverage for everyone in the MA group except for [REDACTED] and [REDACTED].
5. On [REDACTED], the Department created an FIP-related MA net income budget. The undersigned ALJ reviewed this budget with the Petitioner and found the budget for [REDACTED] and found it to be correct.
6. On [REDACTED], the Petitioner requested a hearing to protest the closure of her MA benefits.

### CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, following a Redetermination, the Department closed the Petitioner's and the Petitioner's spouse's MA benefits. Subsequently, the Petitioner met with the Department. According to the Department, that meeting caused the Department to reevaluate the Petitioner's MA benefits and find that both she and her spouse qualified for MA G2 benefits with a deductible of \$ [REDACTED] per month. (BEM 530, January 2014).

It should be noted that the evidence of the above information concerning the Respondent's MA benefits is not completed at this time; and this order will reflect the necessity of removing the MA termination from both [REDACTED] and [REDACTED] MA benefits.

### DECISION AND ORDER


The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department **did not** act in accordance with Department policy when it closed the Petitioner's MA benefits.

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reinstate the Petitioner's and the Petitioner's spouse's MA benefits effective the date of closure, [REDACTED].
2. Supplement for any benefits not provided due to the Department's [REDACTED] MA closures.
