HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 To 273.18; 42 CFR 431.200 To 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on [REDACTED], from Detroit, Michigan. The Petitioner was represented by Petitioner. The Department of Health and Human Services (Department) was represented by [REDACTED] Eligibility Specialist.

ISSUE

Did the Department properly deny the Petitioner's Food Assistance Program (FAP) benefits application?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED], the Petitioner filed an FAP application.
2. On [REDACTED], the Department sent the Petitioner a Verification Checklist (VCL) requesting various pieces of information/documentation.
3. On [REDACTED], the Department sent the Petitioner a Notice of Case Action informing her that her FAP application had been denied.
4. On [REDACTED], the Petitioner's employer, [REDACTED], provided documentation showing the Petitioner's employment began [REDACTED], and ended [REDACTED].

5. On [REDACTED], the Petitioner requested a hearing to protest the denial of her FAP application.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp Program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the Federal Regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-119b, and Mich Admin Code, R 400.3001-.3011.

In this case, the Petitioner testified that she did not provide the end-of-work date because she was hoping to be called back to work.

The Department denied the Petitioner's FAP application because she failed to provide documentation.

The Petitioner's employer sent documentation of her begin-and-end-of-employment dates on [REDACTED].

This is after the date specified in the VCL and after the Department had denied the Petitioner's FAP application for failure to document the end of her employment.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied the Petitioner's FAP application.

Accordingly, the Department's decision is **AFFIRMED**.
