## **HEARING DECISION**

#### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp Program] Is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the Federal Regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, the Petitioner testified that she did not provide the end-of-work date because she was hoping to be called back to work.

The Department denied the Petitioner's FAP application because she failed to provide documentation.

This is after the date specified in the VCL and after the Department had denied the Petitioner's FAP application for failure to document the end of her employment.

## **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied the Petitioner's FAP application.

Accordingly, the Department's decision is **AFFIRMED**.
