HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on March 1, 2017, from Lansing, Michigan. Petitioner personally appeared and testified.

The Department of Health and Human Services (Department) was represented by Assistance Payment Supervisor, and Assistance Payment Worker, and testified on behalf of the Department. The Department submitted nine exhibits which were admitted into evidence. The record was closed at the conclusion of the hearing.

Prior to the closure of the hearing record, it was determined that Petitioner's request for hearing was untimely. Petitioner indicated that she had received the Notice of State SSI Payment Change dated March 25, 2016, informing her that her quarterly State SSI payment had been cancelled and if she did not agree with the action, she had 90 days to request a hearing. Petitioner did not request a hearing contesting the cancelation until January 17, 2017.

The regulations regarding the hearing and appeal process for applicants and recipients of public assistance are in 2015 Michigan Administrative Code, Rule 400.904. Any hearing request which protests a denial, reduction or termination of benefits must be filed within 90 days of the mailing of the negative action notice. R 400.904(4).

Therefore, it is not necessary for the Administrative Law Judge to decide the matter that was in dispute. Pursuant to Mich Admin R 400.904(4), Petitioner's hearing request is **HEREBY DISMISSED**, because Petitioner's hearing request was not submitted timely.
