HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16 and 45 CFR 235.110; and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on February 28, 2017, from Lansing, Michigan. The Department was represented by [REDACTED], Recoupment Specialist. The Petitioner appeared on her own behalf.

ISSUE

Did Petitioner receive an over-issuance (OI) of Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a recipient of FAP benefits from the Department.
2. The Department alleges Petitioner received a FAP OI during the period July 1, 2016, through November 30, 2016, due to Department error.
3. The Department alleges that Petitioner received \$ [REDACTED] OI that is still due and owing to the Department.
4. The Department had originally alleged that Petitioner received an OI due to client error, for the period of December 1, 2015 through November 30, 2016, in the amount of \$ [REDACTED]. During the course of the hearing, the Department stated

Petitioner had signed a repayment agreement regarding \$ [REDACTED] in FAP OI for the period of December 1, 2015 through June 30, 2016, and the Department thereby verbally amended its pleadings as stated above.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), and Department of Health and Human Services Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

The Department presented evidence that Petitioner was an on-going FAP recipient. Petitioner's household income changed, and she reported that change to the Department sometime after the fact. The Department did not act timely in changing Petitioner's address. The OI is summarized in Exhibit A, Page 9, and the monthly budgets for the months of the OI are found at pages 24-33.

As stated in BAM 700 (1/1/16) p 1, "When a client group receives more benefits than it is entitled to receive, MDHHS must attempt to recoup the overissuance." That is true regardless of whether the error was a "client error" or an "agency error." The policy contains the imperative "must attempt to recoup the overissuance." There is no discretion on the part of the Department or the Administrative Law Judge.

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, finds that the Department established a FAP benefit OI to Petitioner totaling \$ [REDACTED].

DECISION AND ORDER


Accordingly, the Department is **MODIFIED**.

The Department is **ORDERED** to reduce the amount of OI to be recouped from \$ [REDACTED] to \$ [REDACTED] for the period of July 1, 2016 through November 30, 2016.

The Department is **ORDERED** to initiate collection procedures for a \$ [REDACTED] OI in accordance with Department policy.

This Decision does not modify in anyway the repayment agreement Petitioner signed regarding an Intentional Program Violation.
