HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on March 22, 2017, from Detroit, Michigan. The Petitioner was represented by Petitioner. The Department of Health and Human Services (Department) was represented by [REDACTED] [REDACTED] Hearing Facilitator.

ISSUE

Did the Department properly determine Petitioner's eligibility for FAP benefits effective [REDACTED]

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner is an ongoing FAP recipient.
2. On [REDACTED], Petitioner submitted a rent receipt and information showing that he pays a monthly electric expense.
3. On [REDACTED], the Department sent Petitioner a Notice of Case Action which notified Petitioner that his FAP benefits had increased to \$[REDACTED] per month.
4. On [REDACTED], Petitioner filed a Request for Hearing disputing the Department's actions.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Petitioner filed a Request for Hearing as he did not agree with the Department's determination that he was eligible for FAP benefits in the amount of \$ [REDACTED] per month. On [REDACTED], Petitioner submitted a Housing Voucher which revealed that he pays \$ [REDACTED] per month as a rent expense. Petitioner also submitted a utility bill which indicated that he was required to pay an electric expense only. As a result, the Department redetermined Petitioner's eligibility for FAP benefits. The Department submitted a budget in support of its position that it properly determined Petitioner's eligibility for FAP benefits.

Petitioner receives \$ [REDACTED] in unearned income. Petitioner also receives a State Supplement Payment in the amount of [REDACTED] per quarter, which the Department budgets at a rate of \$ [REDACTED] per month. Thus, Petitioner's monthly income is \$ [REDACTED]. Based on Petitioner's circumstances, Petitioner was eligible to receive a standard deduction of \$ [REDACTED] based on his one person group size. RFT 255, p. 1. (October 2016). Petitioner was also eligible to receive a shelter deduction in the amount of \$ [REDACTED] per month. BEM 556. (July 2013). When the standard deduction and the shelter deduction are subtracted from Petitioner's income, the net income amount is \$ [REDACTED].

On [REDACTED], the Department sent Petitioner a Notice of Case Action, which notified him that his FAP benefits would increase to \$ [REDACTED] monthly effective [REDACTED]. Based on the information available to the Department, and based upon a net income of [REDACTED], it properly determined that Petitioner was entitled to a FAP benefit amount of \$ [REDACTED] per month. RFT 260 (October 2016), p. 24.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it decreased Petitioner's FAP benefits to [REDACTED] per month effective [REDACTED].

Accordingly, the Department's decision is **AFFIRMED**.
