HEARING DECISION

Upon the request for a hearing by the Department of Health and Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16 and 45 CFR 235.110; and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on April 18, 2017, from Lansing, Michigan. The Department was represented by Recoupment Specialist.

Respondent did not appear. This matter having been initiated by the Department and due notice having been provided to Respondent, the hearing was held in Respondent's absence in accordance with Department of Health and Human Services Bridges Administrative Manual (BAM) 725.

ISSUE

Did Respondent receive an over-issuance (OI) of Food Assistance Program (FAP) due to Client error?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Respondent was a recipient of FAP benefits from the Department.
- 2. On February 14, 2012, the Respondent applied for FAP benefits for himself and stated that he had no income because he lost his job. Department Exhibit 1, pgs. 38-60.

- 3. On March 14, 2012, the Department sent the Respondent a Notice of Case Action, DHS 1605, where the Respondent was informed that he had a group size of 1 with no monthly income. Department Exhibit 1, pgs. 33-37.
- 4. The Respondent failed to report his Unemployment Compensation Benefits (UCB) to the Department as required in policy within 10 days when he first received them on June 29, 2012 through May 27, 2013. Department Exhibit 1, pgs. 22-27.
- 5. The Department alleges Respondent received a FAP OI during the period August 1, 2012, through February 28, 2013, due to **Respondent's** error.
- 6. The Department alleges that Respondent received \$ OI that is still due and owing to the Department.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), and Department of Health and Human Services Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

Additionally, Respondent was a recipient of FAP benefits from the Department. On February 14, 2012, the Respondent applied for FAP benefits for himself and stated that he had no income because he lost his job. Department Exhibit 1, pgs. 38-60. On March 14, 2012, the Department sent the Respondent a Notice of Case Action, DHS 1605, where the Respondent was informed that he had a group size of 1 with no monthly income. Department Exhibit 1, pgs. 33-37.

The Respondent failed to report his Unemployment Compensation Benefits (UCB) to the Department as required in policy within 10 days when he first received them on June 29, 2012 through May 27, 2013. Department Exhibit 1, pgs. 22-27. The Department alleges Respondent received a FAP OI during the period August 1, 2012, through February 28, 2013, due to **Respondent's** error. The Department alleges that Respondent received \$ OI that is still due and owing to the Department. BAM 105, 715, and 725. BEM 500 series.

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, finds that the Department **did** establish a FAP benefit OI to Respondent totaling

DECISION AND ORDER

Accordingly, the Department is **AFFIRMED**.

The Department is ORDERED to initiate collection procedures for a FAP \$ OI in accordance with Department policy.
