HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on [REDACTED], from Detroit, Michigan. The Petitioner was presented and represented by [REDACTED], Authorized Hearing Representative. The Department of Health and Human Services (Department) was represented by [REDACTED] Hearing Facilitator and [REDACTED], Assistance Payment Worker.

ISSUE

Did the Department properly determine Petitioner's eligibility for FAP benefits effective [REDACTED]?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner is an ongoing FAP recipient.
2. Petitioner timely submitted a Redetermination.
3. On [REDACTED], the Department sent Petitioner a Notice of Case Action which notified Petitioner that her FAP benefits had been approved for [REDACTED] per month effective [REDACTED].

4. On [REDACTED], a Request for Hearing was filed disputing the Department's actions.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-119b, and Mich Admin Code, R 400.3001-.3011.

In this case, Petitioner submitted a timely Redetermination to the Department. The Department indicated that Petitioner indicated that one of her daughters had moved from the home. Petitioner and her son receive RSDI income. Petitioner also receives child support. The Department submitted a budget in support of its position that it properly determined Petitioner's eligibility for FAP benefits.

Petitioner testified that she pays a Part B monthly premium in the amount of \$ [REDACTED] per month. The budget submitted by the Department did not provide for an ongoing medical expense. At the hearing, the Department agreed that Petitioner was entitled to the deduction. Because the Department failed to provide Petitioner with an ongoing medical expense deduction, it failed to properly determine her eligibility for FAP benefits.

DECISION AND ORDER


The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with Department policy when it determined that Petitioner was eligible for FAP benefits in the amount of [REDACTED] per month effective [REDACTED].

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Redetermine Petitioner's eligibility for FAP benefits effective [REDACTED]
2. Issue supplements that Petitioner was eligible to receive but did not effective [REDACTED]; and
3. Notify Petitioner and her AHR in writing of its decision.
