HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10 After due notice, telephone hearing was held on May 25, 2017, from Lansing, Michigan. Participants on behalf of the Department of Health and Human Services (Department) included Assistant Attorney General [REDACTED] Assistant Attorney General [REDACTED] and [REDACTED] Recoupment Specialist. Petitioner appeared for the hearing and was represented by her attorney [REDACTED]

ISSUE

Did the Department properly determine that the Petitioner received an overissuance of Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner received Food Assistance Program (FAP) benefits totaling \$ [REDACTED] from April 1, 2015, through September 30, 2015.
2. Petitioner does not dispute that she was not eligible for Food Assistance Program (FAP) benefits from April 1, 2015, through September 30, 2015.
3. On March 16, 2017, the Department sent Petitioner a Notice of Overissuance (DHS-4358-A).
4. On March 27, 2017, the Department received Petitioner's request for a hearing.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Clients must report changes in circumstance that potentially affect eligibility or benefit amount within 10 days of receiving the first payment reflecting the change. Changes that must be reported include starting employment and increases in earned income received by the benefit group. Department of Human Services Bridges Assistance Manual (BAM) 105 (October 1, 2016), pp 1-20.

When a client group receives more benefits than it is entitled to receive, the Department must attempt to recoup the overissuance. An agency error is caused by incorrect action (including delayed or no action) by Department staff or Department processes. A client error occurs when the client received more benefits than they were entitled to because the client gave incorrect or incomplete information to the department. Client and agency errors are not pursued if the estimated amount is less than \$ [REDACTED] per program. Department of Health and Human Services Bridges Administrative Manual (BAM) 700 (May 1, 2014), pp 1-9.

Overissuance balances on inactive cases must be repaid by lump-sum or monthly cash payments unless collection is suspended. Department of Health and Human Services Bridges Administrative Manual (BAM) 725 (July 1, 2014), p 8.

Petitioner received FAP benefits totaling \$ [REDACTED] from April 1, 2015, through September 30, 2015. Petitioner does not dispute that she was not eligible for these benefits and that she received an overissuance of FAP benefits. On March 20, 2017, the Department sent Petitioner a Notice of Overissuance.


The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, finds that the Department has establish a Food Assistance Program (FAP) benefit overissuance to Petitioner totaling \$ [REDACTED]

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.

The Department is ORDERED to initiate collection procedures for an \$ [REDACTED] overissuance in accordance with Department policy.
