HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 42 CFR 431.200 to 431.250; and 45 CFR 205.10. After due notice, a telephone hearing was held on [REDACTED], from [REDACTED], Michigan. Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by [REDACTED], Eligibility Specialist.

ISSUE

Whether the Department properly determined that Petitioner was not disabled for purposes of the State Disability Assistance (SDA) benefit programs?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED], Petitioner applied for SDA.
2. On [REDACTED], the Medical Review Team (MRT) denied Petitioner's application for SDA, per BEM 261, because the nature and severity of Petitioner's impairments would not preclude work activity at the above stated level for 90 days and is capable of performing other work per 20 CFR 416.920(f).
3. On [REDACTED], the Department Caseworker sent Petitioner a notice that her application was denied.
4. On [REDACTED], the Department received a hearing request from Petitioner, contesting the Department's negative action.

5. Petitioner is a [REDACTED]-year-old woman, whose date of birth is [REDACTED]. Petitioner is [REDACTED]' [REDACTED]" tall, and weighs [REDACTED] pounds. Petitioner completed High School. Petitioner can read, write, and do basic math. Petitioner was last employed as a funeral home assistant in [REDACTED]. She was also employed as a sales clerk, mall representative, and a resident assistant at a nursing home.
6. Petitioner's alleged impairments are carpal tunnel syndrome, Reynaud's Syndrome in hands, bipolar disorder, type 1 diabetes, diabetic neuropathy in legs and feet, rheumatoid arthritis, fibromyalgia, and degenerative disc disease with sciatica.
7. Petitioner was seen for an independent medical examination at [REDACTED] on [REDACTED]. Her chief complaints were carpal tunnel syndrome, diabetes, hypothyroidism, neuropathy, sciatica, rheumatoid arthritis, fibromyalgia, and mental health issues. The independent medical examiner's clinical impression was brittle diabetes, rheumatoid arthritis, fibromyalgia, degenerative disc disease, sciatica, Raynaud's syndrome, carpal tunnel syndrome, neuropathy, bipolar disorder, depression, social anxiety, and manic episodes. She had an essentially normal physical examination, except some physical maneuvers caused pain. Department Exhibit 1, pgs. 194-201.
8. On [REDACTED], Petitioner's treating psychiatrist submitted a Medication Review Note. She was diagnosed with major depressive disorder, recurrent, moderate; obsessive compulsive disorder, unspecified; anxiety disorder, unspecified; generalized anxiety disorder; panic disorder without agoraphobia; and obsessive compulsive personality disorder. Petitioner has had some improvement with her medications and they were adjusted accordingly. There was no evidence of a severe thought disorder or risk factors. Department Exhibit 1, pgs. 89-95.
9. On [REDACTED], Petitioner was seen by her treating physician. She was diagnosed with bipolar disorder, hip pain, radiculopathy in the lumbar region, peripheral neuropathy, carpal tunnel syndrome, anxiety, and depression. Petitioner was positive for a headache, decreased memory, numbness and tingling, and depression. She had an essentially normal physical examination. She was to increase her water intake to 6 to 8 glasses a day. She was also to exercise daily with back and neck exercises reviewed. Department Exhibit 1, pgs. 273-275.
10. On [REDACTED], Petitioner was seen by her endocrine specialist for an endocrine evaluation. Her A1C was 7.0 high improving. She was to work on diet and exercise. Her medications were continued or adjusted accordingly. Department Exhibit 1, pgs. 139-142.
11. On [REDACTED], Petitioner underwent a psychiatric evaluation with [REDACTED]. She was diagnosed with major depressive

disorder, recurrent, moderate; obsessive compulsive disorder, anxiety disorder, unspecified; generalized anxiety disorder; panic disorder without agoraphobia; and obsessive compulsive personality disorder. There was no evidence of a severe thought disorder or risk factors. Her medications were reviewed and adjusted accordingly. Department Exhibit 1, pgs. 103-109.

12. On [REDACTED], Petitioner underwent an advanced occupational therapy assessment at [REDACTED]. She had a diagnosis of diabetes, rheumatoid arthritis, and lumbago. Petitioner functioned at the sedentary demand level. She was able to carry 15 pounds 100 feet at waist level. Petitioner was able to do the push/pull activity. She was able to sit for 40 minutes and stand for 15 minutes. Petitioner complained about the tasks required for the testing. Department Exhibit 1, pgs. 390-396.
13. On [REDACTED], Petitioner underwent an x-ray of the bilateral hands. The radiologist's clinical impression was no evidence of recent/acute fractures of the hands or significant arthritic changes. Department Exhibit 1, pg. 134.
14. On [REDACTED], Petitioner underwent a MRI of the lumbar spine without contrast for a clinical history of back pain. The radiologist's clinical impression was central disc protrusion at L4-L5 resulting in mild central canal narrowing. There was facet joint hypertrophy bilaterally at the L4-L5 level. There was also mild left neural foramina encroachment. There were no other significant abnormalities in the lumbar spine. Department Exhibit 1, pgs. 132-133.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT).

The State Disability Assistance (SDA) program, which provides financial assistance for disabled persons, was established by 2004 PA 344. The Department administers the SDA program pursuant to 42 CFR 435, MCL 400.10 *et seq.* and Mich Admin Code, Rules 400.3151 – 400.3180. A person is considered disabled for SDA purposes if the person has a physical or mental impairment which meets federal Supplemental Security Income (SSI) disability standards for at least ninety days. Receipt of SSI benefits based on disability or blindness, or the receipt of MA benefits based on disability or blindness, automatically qualifies an individual as disabled for purposes of the SDA program.

The Department conforms to State statute in administering the SDA program.

2000 PA 294, Sec. 604, of the statute states:

Sec. 604. (1) The department shall operate a state disability assistance program. Except as provided in

subsection (3), persons eligible for this program shall include needy citizens of the United States or aliens exempted from the supplemental security income citizenship requirement who are at least 18 years of age or emancipated minors meeting 1 or more of the following requirements:

- (a) A recipient of supplemental security income, social security, or medical assistance due to disability or 65 years of age or older.
- (b) A person with a physical or mental impairment which meets federal supplemental security income disability standards, except that the minimum duration of the disability shall be 90 days. Substance abuse alone is not defined as a basis for eligibility.

Pursuant to Federal Rule 42 CFR 435.540, the Department uses the Federal Supplemental Security Income (SSI) policy in determining eligibility for disability. Under SSI, disability is defined as:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.... 20 CFR 416.905.

A set order is used to determine disability. Current work activity, severity of impairments, residual functional capacity, past work, age, or education and work experience are reviewed. If there is a finding that an individual is disabled or not disabled at any point in the review, there will be no further evaluation. 20 CFR 416.920.

Medical evidence may contain medical opinions. Medical opinions are statements from physicians and psychologists or other acceptable medical sources that reflect judgments about the nature and severity of the impairment(s), including symptoms, diagnosis and prognosis, what an individual can do despite impairment(s), and the physical or mental restrictions. 20 CFR 416.927(a)(2).

The Administrative Law Judge is responsible for making the determination or decision about whether the statutory definition of disability is met. The Administrative Law Judge reviews all medical findings and other evidence that support a medical source's statement of disability. 20 CFR 416.927(e).

For mental disorders, severity is assessed in terms of the functional limitations imposed by the impairment. Functional limitations are assessed using the criteria in paragraph (B) of the listings for mental disorders (descriptions of restrictions of activities of daily living, social functioning; concentration, persistence or pace; and ability to tolerate

increased mental demands associated with competitive work). 20 CFR, Part 404, Subpart P, Appendix 1, 12.00(C).

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements and other functions will be evaluated. 20 CFR 416.945(a).

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium and heavy. These terms have the same meaning as they have in the Dictionary of Occupational Titles, published by the Department of Labor. 20 CFR 416.967.

Pursuant to 20 CFR 416.920, a five-step sequential evaluation process is used to determine disability. An individual's current work activity, the severity of the impairment, the residual functional capacity, past work, age, education and work experience are evaluated. If an individual is found disabled or not disabled at any point, no further review is made.

The first step is to determine if an individual is working and if that work is "substantial gainful activity" (SGA). If the work is SGA, an individual is not considered disabled regardless of medical condition, age or other vocational factors. 20 CFR 416.920(b).

Secondly, the individual must have a medically determinable impairment that is "severe" or a combination of impairments that is "severe." 20 CFR 404.1520(c). An impairment or combination of impairments is "severe" within the meaning of regulations if it significantly limits an individual's ability to perform basic work activities. An impairment or combination of impairments is "not severe" when medical and other evidence establish only a slight abnormality or a combination of slight abnormalities that would have no more than a minimal effect on an individual's ability to work. 20 CFR 404.1521; Social Security Rulings (SSRs) 85-28, 96-3p, and 96-4p. If Petitioner does not have a severe medically determinable impairment or combination of impairments, Petitioner is not disabled. If Petitioner has a severe impairment or combination of impairments, the analysis proceeds to the third step.

The third step in the process is to assess whether the impairment or combination of impairments meets a Social Security listing. If the impairment or combination of impairments meets or is the medically equivalent of a listed impairment as set forth in Appendix 1 and meets the durational requirements of 20 CFR 404.1509, the individual is considered disabled. If it does not, the analysis proceeds to the next step.

Before considering step four of the sequential evaluation process, the trier must determine Petitioner's residual functional capacity. 20 CFR 404.1520(e). An individual's residual functional capacity is his ability to do physical and mental work activities on a sustained basis despite limitations from his impairments. In making this

finding, the trier must consider all of Petitioner's impairments, including impairments that are not severe. 20 CFR 404.1520(e) and 404.1545; SSR 96-8p.

The fourth step of the process is whether Petitioner has the residual functional capacity to perform the requirements of his past relevant work. 20 CFR 404.1520(f). The term past relevant work means work performed (either as Petitioner actually performed it or as is it generally performed in the national economy) within the last 15 years or 15 years prior to the date that disability must be established. If Petitioner has the residual functional capacity to do past relevant work, then Petitioner is not disabled. If Petitioner is unable to do any past relevant work or does not have any past relevant work, the analysis proceeds to the fifth step.

In the fifth step, an individual's residual functional capacity is considered in determining whether disability exists. An individual's age, education, work experience and skills are used to evaluate whether an individual has the residual functional capacity to perform work despite limitations. 20 CFR 416.920(e).

Here, Petitioner has satisfied requirements as set forth in steps one and two of the sequential evaluation. However, Petitioner's impairments do not meet a listing as set forth in Appendix 1, 20 CFR 416.926 for step 3. Therefore, vocational factors will be considered to determine Petitioner's residual functional capacity to do relevant work and past relevant work.

In the present case, Petitioner was seen for an independent medical examination at [REDACTED] on [REDACTED]. Her chief complaints were carpal tunnel syndrome, diabetes, hypothyroidism, neuropathy, sciatica, rheumatoid arthritis, fibromyalgia, and mental health issues. The independent medical examiner's clinical impression was brittle diabetes, rheumatoid arthritis, fibromyalgia, degenerative disc disease, sciatica, Raynaud's syndrome, carpal tunnel syndrome, neuropathy, bipolar disorder, depression, social anxiety, and manic episodes. She had an essentially normal physical examination except some physical maneuvers caused pain. Department Exhibit 1, pgs. 194-201.

On [REDACTED], Petitioner's treating psychiatrist submitted a Medication Review Note. On [REDACTED], Petitioner underwent an advanced occupational therapy assessment at [REDACTED]. She had a diagnosis of diabetes, rheumatoid arthritis, and lumbago. Petitioner functioned at the sedentary demand level. She was able to carry 15 pounds 100 feet at waist level. Petitioner was able to do the push/pull activity. She was able to sit for 40 minutes and stand for 15 minutes. Petitioner complained about the tasks required for the testing. Department Exhibit 1, pgs. 390-396.

On [REDACTED], Petitioner underwent an x-ray of the bilateral hands. The radiologist's clinical impression was no evidence of recent/acute fractures of the hands or significant arthritic changes. Department Exhibit 1, pg. 134.

On [REDACTED], Petitioner underwent a MRI of the lumbar spine without contrast for a clinical history of back pain. The radiologist's clinical impression was central disc protrusion at L4-L5 resulting in mild central canal narrowing. There was facet joint hypertrophy bilaterally at the L4-L5 level. There was also mild left neural foramina encroachment. There was no other significant abnormalities in the lumbar spine. Department Exhibit 1, pgs. 132-133.

This Administrative Law Judge finds that Petitioner is physically limited, but not to the limit that she claims. The objective medical evidence on the records supports a finding of at least light work. Her MRI showed that she was mildly impaired in her back. She is therapy and taking medications for her mental impairments based on her medical records. There was no evidence of a severe thought disorder or risk factors. She will be limited to simple and unskilled light work.

It is the finding of this Administrative Law Judge, based upon the medical evidence and objective, physical and psychological findings that Petitioner testified that she does perform most of her daily living activities. Petitioner does feel that her condition has worsened because of her uncontrolled sugars. Petitioner stated that she does have mental impairments where she is taking not medication, but not in therapy. This is in

3. the kinds of work which exist in significant numbers in the national economy which Petitioner could perform despite her limitations. 20 CFR 416.966.

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements and other functions will be evaluated. 20 CFR 416.945(a).

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium and heavy. These terms have the same meaning as they have in the Dictionary of Occupational Titles, published by the Department of Labor. 20 CFR 416.967.

Sedentary work. Sedentary work involves lifting no more than 10 pounds at a time and occasionally lifting or carrying articles like docket files, ledgers, and small tools. Although a sedentary job is defined as one which involves sitting, a certain amount of walking and standing is often necessary in carrying out job duties. Jobs are sedentary if walking and standing are required occasionally and other sedentary criteria are met. 20 CFR 416.967(a).

Light work. Light work involves lifting no more than 20 pounds at a time with frequent lifting or carrying of objects weighing up to 10 pounds. Even though the weight lifted may be very little; a job is in this category when it requires a good deal of walking or standing, or when it involves sitting most of the time with some pushing and pulling of arm or leg controls. 20 CFR 416.967(b).

Medium work. Medium work involves lifting no more than 50 pounds at a time with frequent lifting or carrying of objects weighing up to 25 pounds. If someone can do medium work, we determine that he or she can also do sedentary and light work. 20 CFR 416.967(c).

Heavy work. Heavy work involves lifting no more than 100 pounds at a time with frequent lifting or carrying of objects weighing up to 50 pounds. If someone can do heavy work, we determine that he or she can also do medium, light, and sedentary work. 20 CFR 416.967(d).

At Step 5, Petitioner can meet the physical requirements of light work, based upon Petitioner's physical abilities. Under the Medical-Vocational guidelines, a younger aged individual with a high school education, and an unskilled work history, who is limited to light work, is considered not disabled. 20 CFR 404, Subpart P, Appendix 2, Rule

202.20. The Medical-Vocational guidelines are not strictly applied with non-exertional impairments such as bipolar disorder. 20 CFR 404, Subpart P, Appendix 2, Section 200.00. Using the Medical-Vocational guidelines as a framework for making this decision and after giving full consideration to Petitioner's mental and physical impairments, the Administrative Law Judge finds that Petitioner could perform simple and unskilled, light work and that Petitioner does not meet the definition of disabled under the SDA program.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds Petitioner not disabled for purposes of the SDA benefit program. Petitioner could perform simple and unskilled, light work and that Petitioner does not meet the definition of disabled under the SDA program.

Accordingly, the Department's determination is **AFFIRMED**.
