#### **HEARING DECISION**

Upon the request for a hearing by the Department of Health and Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16, 42 CFR 431.230(b), and 45 CFR 235.110, and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on July 6, 2017, from Lansing, Michigan. The Department was represented by Recoupment Specialist. Respondent was represented by herself and her husband,

#### ISSUE

Did Respondent receive an over-issuance (OI) of Food Assistance Program (FAP) due to Department error?

# **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Respondent was a recipient of FAP benefits from the Department.
- 2. The Department alleges Respondent received a FAP OI during the period July 1, 2015, through June 30, 2016, due to **Department's** error.
- 3. The Department alleges that Respondent received \$ OI that is still due and owing to the Department.

## **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), and Department of Health and Human Services Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

Additionally, Respondent was a recipient of FAP benefits from the Department. The Department alleges Respondent received a FAP OI during the period July 1, 2015 through June 30, 2016, due to **Department's** error. The Department alleges that Respondent received \$ OI that is still due and owing to the Department. BAM 705 and 725. BEM 554 and 500 series.

During the hearing, the Recoupment Specialist stated that Respondent did not pay her Medicaid Part B since Respondent had been approved for QMB cost share where the State of Michigan had been paying the However, the Department continued to budget the expense for FAP even though the expense was being paid by the State of Michigan. As a result, the Respondent received an overissuance of FAP benefits. Department Exhibit 1, pgs. 1-59.

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, finds that the Department **did** establish a FAP benefit OI to Respondent totaling

### **DECISION AND ORDER**

Accordingly, the Department is **AFFIRMED**.

The Department is ORDERED to initiate collection procedures for a FAP \$ OI in accordance with Department policy.
