HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on August 23, 2017, from Lansing, Michigan. Petitioner was represented by his wife and household member, [REDACTED]. [REDACTED] also appeared and testified for Petitioner. The Department of Health and Human Services (Department) was represented by [REDACTED], Recoupment Specialist. Department Exhibit 1, pp. 1-29 was received and admitted.

ISSUE

Did the Department properly determine that Petitioner received an overissuance (OI) of Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On July 6, 2017, Notice of Overissuance was sent to Petitioner alleging that he received an overissuance of FAP benefits in the amount of \$ [REDACTED] due to agency error.
2. On July 14, 2017, Petitioner requested hearing disputing the overissuance determination.

3. Household member [REDACTED] had employment income that was not budgeted from February 1, 2017, through June 30, 2017.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Overissuance

When a client group receives more benefits than entitled to receive, the Department must attempt to recoup the OI. BAM 700, p. 1.

AGENCY ERROR EXCEPTIONS

FIP, SDA, CDC and FAP

Agency error overissuances are not pursued if the estimated amount is less than \$250 per program. BAM 705 p.1

In this case, on December 29, 2016, Petitioner submitted semiannual contact report disclosing income for household member [REDACTED] (Petitioner Exhibit 1, p.25) The Department failed to process this submission. From February 1, 2017, through June 30, 2017, Petitioner received \$ [REDACTED] in FAP benefits that he was not entitled to due to agency error. Since the overissuance resulted due to agency error Department policy requires that the Department recoup the overissuance if it is over \$250. BAM 705

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, finds that the Department **did** establish a FAP benefit OI to Respondent totaling \$ [REDACTED] due to Department error.

DECISION AND ORDER

Accordingly, the Department is **AFFIRMED**.
