HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on September 5, 2017, from Lansing, Michigan. Petitioner was represented by herself. The Department was represented by Hearing Facilitator [REDACTED] [REDACTED]

ISSUE

Did the Department properly close Petitioner's Medical Assistance (MA) beginning August 1, 2017?

Did the Department properly close Petitioner's Food Assistance Program (FAP) beginning August 1, 2017?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an ongoing recipient of Medical Assistance (MA) and Food Assistance Program (FAP) benefits.
2. On April 7, 2017, Petitioner was sent a New Hire Client Notice (DHS-4635) requesting verification of earned income. The verification was due back on April 17, 2017.
3. On July 13, 2017, Petitioner was sent notice that her Medical Assistance (MA) and Food Assistance Program (FAP) would close beginning August 1, 2017.
4. On July 20, 2017, Petitioner submitted a hearing request.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).


The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

During this hearing Petitioner testified that she does not remember receiving the New Hire Client Notice (DHS-4635). She also testified that she did reside at the address where the New Hire Client Notice (DHS-4635) was sent, until at least June 2017. Since the Department sent the form to a proper address of record, the responsibility to return the form is on Petitioner. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's Medical Assistance (MA) and Food Assistance Program (FAP) beginning August 1, 2017.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
