### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on September 25, 2017, from Michigan. The Petitioner was represented by herself. The Department was represented by

# **ISSUE**

Did the Department of Health and Human Services (Department) properly close Petitioner's Food Assistance Program (FAP) benefits?

### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On June 5, 2017, the Department sent Petitioner a Redetermination (DHS-1010) with a July 3, 2017, due date. Exhibit A, pp 3-10.
- 2. On June 21, 2017, the Department notified Petitioner that her eligibility interview had been rescheduled from July 3, 2017, to July 12, 2017. Exhibit A, p 13.
- 3. On July 11, 2017, the Department sent Petitioner a Notice of Missed Interview (DHS-254), instructing her that was her responsibility to reschedule her interview to avoid any loss of benefits. Exhibit A, p 14.
- 4. On August 17, 2017, the Department received Petitioner's request for a hearing protesting the closure of her Food Assistance Program (FAP) benefits.

# **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Clients must cooperate with the local office in determining initial and ongoing eligibility and this includes the completion of necessary forms. Department of Human Services Bridges Assistance Manual (BAM) 105 (October 1, 2016), p 8.

Verification means documentation or other evidence to establish the accuracy of the client's verbal or written statements. Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as a local office option, or information regarding an eligibility factor is unclear, inconsistent, incomplete, or contradictory. The Department uses documents, collateral contacts, or home calls to verify information. A collateral contact is a direct contact with a person, organization, or agency to verify information from the client. When documentation is not available, or clarification is needed, collateral contact may be necessary. Department of Human Services Bridges Assistance Manual (BAM) 130 (April 1, 2017), pp 1-9.

On June 5, 2017, the Department sent Petitioner a Redetermination (DHS-1010) with a July 3, 2017, due date. Petitioner was expected to complete the Redetermination form and return it so an eligibility interview could take place on July 3, 2017. On June 21, 2017, the Department rescheduled Petitioner's eligibility interview to July 11, 2017.

However, Petitioner was still expected to return the Redetermination (DHS-1010) form by July 3, 2017, or at least before her interview. Without a completed Redetermination form, an interview could not take place. Petitioner could have avoided an interruption of her FAP benefits by returning the Redetermination form and rescheduling her interview before the end of July.

No evidence was presented on the record that the Redetermination form was returned to the Department and her FAP benefits automatically closed at the end of her benefit period.

Petitioner testified that she did not receive the Redetermination (DHS-1010) form.

While a presumption arises that a letter with a proper address and postage will, when placed in the mail be delivered by the postal service, this presumption can be rebutted with evidence that the letter was not received. If such evidence is presented, as it was here, then a question of fact arises regarding whether the letter was received. [Citations omitted.] Goodyear Tire & Rubber Co v Roseville, 468 Mich 947; 664 NW2d 751 (2003).

In this case, the Department presented substantial evidence that it mailed a Redetermination (DHS-1010) to Petitioner's current address of record, and the Petitioner failed to rebut the presumption of receipt.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's Food Assistance Program (FAP) benefits.

# **DECISION AND ORDER**

Accordingly, the Department's decision is AFFIRMED.
