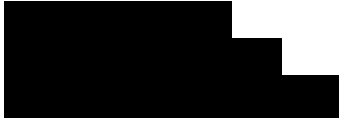

**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 42 CFR 431.200 to 431.250. After due notice, an in-person hearing was held on September 6, 2017, from Big Rapids, Michigan. The Petitioner was represented by himself. The Department of Health and Human Services was represented by [REDACTED] Eligibility Specialist and [REDACTED] Assistance Payments Supervisor.

**ISSUE**

Whether the Department Of Health and Human Service properly determined that Petitioner was not disabled for purposes of the State Disability Assistance (SDA) benefit programs?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On April 3, 2017, the Petitioner applied for SDA.
2. On June 30, 2017, the Medical Review Team (MRT) denied the Petitioner's application for SDA is denied per BEM 261 because the nature and severity of the Petitioner's impairment's would not preclude work activity at the above stated level for 90 days and is capable of performing other work under Medical Vocation Grid Rule 203.15 per 20 CFR 416.920(f).
3. On July 6, 2017, the Department Caseworker sent the Petitioner a notice that his application was denied.

4. On July 17, 2017, the Department received a hearing request from the Petitioner, contesting the Department's negative action.
5. The Petitioner is a [REDACTED] year-old man whose date of birth is [REDACTED]. The Petitioner is 6' tall and weighs 250 pounds. The Petitioner completed the 10<sup>th</sup> grade of High School and has a GED. The Petitioner can read and write and do basic math. The Petitioner was last employed as a laborer at a tire repair shop for 2 weeks in 2010. He was incarcerated from 2001 through 2010. He has no pertinent work history.
6. The Petitioner's alleged impairments are side effect of pain medications, depression, anxiety, muscle cramps in leg, sciatica in back, and arthritis in back, wrists, and knees.
7. The Petitioner was seen by an independent medical examiner for a medical evaluation at [REDACTED] on [REDACTED]. He was seen for an evaluation of severe depression, back pain that radiates down the sides, and an emotional disorder. His blood press was elevated at 151/105. He had an essentially normal physical examination except for his flat affect and emotional disconnect. He was slow moving in all mannerisms of gait, speech, and etc. According to his statement, he has back pain since 2003. He does have a positive Romberg's sign falling backwards. He has dysmetria primarily on the right side as well as dysdiadochokinesia with no fast movement apparent in any way for him. He does have a positive right sided FABERs test. His straight leg raise was negative. The Petitioner did have some mild decrease in his lumbar extension. With extension of his neck, he had a near fall to the back posteriorly. He has a decrease in right sided rotation of his neck as well. His squat was somewhat impaired at 30 to 40% of normal. Department Exhibit 1, pgs. 416-420.
8. On [REDACTED], the Petitioner was seen by an independent psychiatric examiner for a psychiatric/psychological medical examination at [REDACTED]. He was seen for constant back pain and depression. He reported sleep patterns that were restless due to back pain. The Petitioner appeared depressed. He was diagnosed with Persistent Depressive Disorder. His prognosis was moderate to fair. He can manage his own benefit funds, but he should be carefully monitored because of his recent struggles with alcohol. His appears to be able to deal with normal workplace stressors. There was no evidence of a severe thought disorder or risk factors. Department Exhibit 1, pgs. 410-415.
9. On [REDACTED], the Petitioner was seen by his treating physician at [REDACTED] for an office visit. He had chronic midline low back pain without sciatica. The Petitioner was scheduled for an MRI. He stated that chiropractor was helping, but that the back pain persists. He wanted stronger pain medications. The Petitioner had an essentially normal physical examination except that he was positive for back pain. Department Exhibit 1, pgs. 92-96.

10. On [REDACTED], the Petitioner underwent an MRI at [REDACTED]. The radiologist's clinical impression was mild degenerative change in the lumbar spine without central canal stenosis or evidence of nerve root compression. Department Exhibit 1, pgs. 44-45.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT).

The State Disability Assistance (SDA) program, which provides financial assistance for disabled persons, was established by 2004 PA 344. The Department administers the SDA program pursuant to 42 CFR 435, MCL 400.10 *et seq.* and Mich Admin Code, Rules 400.3151 – 400.3180. A person is considered disabled for SDA purposes if the person has a physical or mental impairment which meets federal Supplemental Security Income (SSI) disability standards for at least ninety days. Receipt of SSI benefits based on disability or blindness, or the receipt of MA benefits based on disability or blindness, automatically qualifies an individual as disabled for purposes of the SDA program.

The Department conforms to State statute in administering the SDA program.

2000 PA 294, Sec. 604, of the statute states:

Sec. 604. (1) The department shall operate a state disability assistance program. Except as provided in subsection (3), persons eligible for this program shall include needy citizens of the United States or aliens exempted from the supplemental security income citizenship requirement who are at least 18 years of age or emancipated minors meeting 1 or more of the following requirements:

- (a) A recipient of supplemental security income, social security, or medical assistance due to disability or 65 years of age or older.
- (b) A person with a physical or mental impairment which meets federal supplemental security income disability standards, except that the minimum duration of the disability shall be 90 days. Substance abuse alone is not defined as a basis for eligibility.

Pursuant to Federal Rule 42 CFR 435.540, the Department uses the Federal Supplemental Security Income (SSI) policy in determining eligibility for disability. Under SSI, disability is defined as:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.... 20 CFR 416.905.

A set order is used to determine disability. Current work activity, severity of impairments, residual functional capacity, past work, age, or education and work experience are reviewed. If there is a finding that an individual is disabled or not disabled at any point in the review, there will be no further evaluation. 20 CFR 416.920.

Medical evidence may contain medical opinions. Medical opinions are statements from physicians and psychologists or other acceptable medical sources that reflect judgments about the nature and severity of the impairment(s), including symptoms, diagnosis and prognosis, what an individual can do despite impairment(s), and the physical or mental restrictions. 20 CFR 416.927(a)(2).

The Administrative Law Judge is responsible for making the determination or decision about whether the statutory definition of disability is met. The Administrative Law Judge reviews all medical findings and other evidence that support a medical source's statement of disability. 20 CFR 416.927(e).

For mental disorders, severity is assessed in terms of the functional limitations imposed by the impairment. Functional limitations are assessed using the criteria in paragraph (B) of the listings for mental disorders (descriptions of restrictions of activities of daily living, social functioning; concentration, persistence or pace; and ability to tolerate increased mental demands associated with competitive work). 20 CFR, Part 404, Subpart P, Appendix 1, 12.00(C).

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements and other functions will be evaluated. 20 CFR 416.945(a).

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium and heavy. These terms have the same meaning as they have in the Dictionary of Occupational Titles, published by the Department of Labor. 20 CFR 416.967.

Pursuant to 20 CFR 416.920, a five-step sequential evaluation process is used to determine disability. An individual's current work activity, the severity of the impairment, the residual functional capacity, past work, age, education and work experience are evaluated. If an individual is found disabled or not disabled at any point, no further review is made.

The first step is to determine if an individual is working and if that work is “substantial gainful activity” (SGA). If the work is SGA, an individual is not considered disabled regardless of medical condition, age or other vocational factors. 20 CFR 416.920(b).

Secondly, the individual must have a medically determinable impairment that is “severe” or a combination of impairments that is “severe.” 20 CFR 404.1520(c). An impairment or combination of impairments is “severe” within the meaning of regulations if it significantly limits an individual’s ability to perform basic work activities. An impairment or combination of impairments is “not severe” when medical and other evidence establish only a slight abnormality or a combination of slight abnormalities that would have no more than a minimal effect on an individual’s ability to work. 20 CFR 404.1521; Social Security Rulings (SSRs) 85-28, 96-3p, and 96-4p. If the Petitioner does not have a severe medically determinable impairment or combination of impairments, the Petitioner is not disabled. If the Petitioner has a severe impairment or combination of impairments, the analysis proceeds to the third step.

The third step in the process is to assess whether the impairment or combination of impairments meets a Social Security listing. If the impairment or combination of impairments meets or is the medically equivalent of a listed impairment as set forth in Appendix 1 and meets the durational requirements of 20 CFR 404.1509, the individual is considered disabled. If it does not, the analysis proceeds to the next step.

Before considering step four of the sequential evaluation process, the trier must determine the Petitioner’s residual functional capacity. 20 CFR 404.1520(e). An individual’s residual functional capacity is his ability to do physical and mental work activities on a sustained basis despite limitations from his impairments. In making this finding, the trier must consider all of the Petitioner’s impairments, including impairments that are not severe. 20 CFR 404.1520(e) and 404.1545; SSR 96-8p.

The fourth step of the process is whether the Petitioner has the residual functional capacity to perform the requirements of his past relevant work. 20 CFR 404.1520(f). The term past relevant work means work performed (either as the Petitioner actually performed it or as is it generally performed in the national economy) within the last 15 years or 15 years prior to the date that disability must be established. If the Petitioner has the residual functional capacity to do past relevant work, then the Petitioner is not disabled. If the Petitioner is unable to do any past relevant work or does not have any past relevant work, the analysis proceeds to the fifth step.

In the fifth step, an individual’s residual functional capacity is considered in determining whether disability exists. An individual’s age, education, work experience and skills are used to evaluate whether an individual has the residual functional capacity to perform work despite limitations. 20 CFR 416.920(e).

Here, the Petitioner has satisfied requirements as set forth in steps one and two of the sequential evaluation. However, the Petitioner’s impairments do not meet a listing as set forth in Appendix 1, 20 CFR 416.926 for step 3. Therefore, vocational factors will be

considered to determine the Petitioner's residual functional capacity to do relevant work and past relevant work.

In the present case, the Petitioner was seen by an independent medical examiner for a medical evaluation at [REDACTED] on [REDACTED]. He was seen for an evaluation of severe depression, back pain that radiates down the sides, and an emotional disorder. His blood press was elevated at 151/105. He had an essentially normal physical examination except for his flat affect and emotional disconnect. He was slow moving in all mannerisms of gait, speech, and etc. According to his statement, he has back pain since 2003. He does have a positive Romberg's sign falling backwards. He has dysmetria primarily on the right side as well as dysdiadochokinesia with no fast movement apparent in any way for him. He does have a positive right sided FABERs test. The Petitioner had an essentially normal physical examination except that he was positive for back pain. Department Exhibit 1, pgs. 92-96.

On [REDACTED], the Petitioner underwent an MRI at [REDACTED]. The radiologist's clinical impression was mild degenerative change in the lumbar spine without central canal stenosis or evidence of nerve root compression. Department Exhibit 1, pgs. 44-45.

The Administrative Law Judge finds the Petitioner is physically limited because of his back. He is taking pain medications for his chronic back pain. His MRI showed mild degenerative changes without central canal stenosis or evidence of nerve root compression. He will be limited to light work. The Petitioner is taking medications for his mental impairments, but not in therapy. He has already finished his therapy session with Community Mental Health. There was no evidence of a severe thought disorder or risk factors.

It is the finding of this Administrative Law Judge, based upon the medical evidence and objective, physical and psychological findings that the Petitioner testified that he does perform some of his daily living activities. The Petitioner does feel that his condition has worsened because of his increase in pain and it is harder to do the simple things. The Petitioner stated that he does have mental impairments where he is taking medications, but not in therapy. The Petitioner smokes ½ a pack of cigarettes a day. He stopped drinking over 3 years ago on June 28, 2014, which before he was an alcoholic. He stopped using illegal and illicit drugs of marijuana when he was teenager. The Petitioner did not feel there was any work he could do.

At Step 4, this Administrative Law Judge finds that the Petitioner has not established that he cannot perform any of his prior work. He has no pertinent work history. He was incarcerated from 2001 through 2010. The Petitioner is taking medication for his mental impairments, but not in therapy. There was no evidence of a severe thought disorder or risk factors. He has issues with his back that may limit him to light work. Therefore, the Petitioner is not disqualified from receiving disability at Step 4. The Petitioner is capable of performing work. He does not have a driver's license due to drunk driving. However, the Administrative Law Judge will still proceed through the sequential evaluation process to determine whether or not the Petitioner has the residual functional capacity to perform some other less strenuous tasks than in his prior jobs.

The objective medical evidence on the record is insufficient that the Petitioner lacks the residual functional capacity to perform some other less strenuous tasks than in him previous employment or that he is physically unable to do any tasks demanded of him. The Petitioner's testimony as to his limitation indicates his limitations are non-exertional and exertional.

For mental disorders, severity is assessed in terms of the functional limitations imposed by the impairment. Functional limitations are assessed using the criteria in paragraph (B) of the listings for mental disorders (descriptions of restrictions of activities of daily living, social functioning; concentration, persistence, or pace; and ability to tolerate increased mental demands associated with competitive work).... 20 CFR, Part 404, Subpart P, App. 1, 12.00(C).

In the instant case, the Petitioner testified that he has depression. The Petitioner is taking medication, but not in therapy for his mental impairments. See MA analysis step 2. There was no evidence of a serious thought disorder or risk factors. He is capable of performing work.

In the final step of the analysis, the trier of fact must determine if the Petitioner's impairment(s) prevent the Petitioner from doing other work. 20 CFR 416.920(f). This determination is based upon the Petitioner's:

1. residual functional capacity defined simply as "what can you still do despite your limitations?" 20 CFR 416.945;
2. age, education, and work experience, 20 CFR 416.963-965; and

3. the kinds of work which exist in significant numbers in the national economy which the Petitioner could perform despite her limitations. 20 CFR 416.966.

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements and other functions will be evaluated. 20 CFR 416.945(a).

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium and heavy. These terms have the same meaning as they have in the Dictionary of Occupational Titles, published by the Department of Labor. 20 CFR 416.967.

**Sedentary work.** Sedentary work involves lifting no more than 10 pounds at a time and occasionally lifting or carrying articles like docket files, ledgers, and small tools. Although a sedentary job is defined as one which involves sitting, a certain amount of walking and standing is often necessary in carrying out job duties. Jobs are sedentary if walking and standing are required occasionally and other sedentary criteria are met. 20 CFR 416.967(a).

**Light work.** Light work involves lifting no more than 20 pounds at a time with frequent lifting or carrying of objects weighing up to 10 pounds. Even though the weight lifted may be very little; a job is in this category when it requires a good deal of walking or standing, or when it involves sitting most of the time with some pushing and pulling of arm or leg controls. 20 CFR 416.967(b).

**Medium work.** Medium work involves lifting no more than 50 pounds at a time with frequent lifting or carrying of objects weighing up to 25 pounds. If someone can do medium work, we determine that he or she can also do sedentary and light work. 20 CFR 416.967(c).

**Heavy work.** Heavy work involves lifting no more than 100 pounds at a time with frequent lifting or carrying of objects weighing up to 50 pounds. If someone can do heavy work, we determine that he or she can also do medium, light, and sedentary work. 20 CFR 416.967(d).

At Step 5, the Petitioner can meet the physical requirements of medium work, based upon the Petitioner's physical abilities. Under the Medical-Vocational guidelines, a closely approaching advanced age individual with a high school equivalent education,



and no pertinent work history, who is limited to light work, is considered not disabled. 20 CFR 404, Subpart P, Appendix 2, Rule 203.13. The Medical-Vocational guidelines are not strictly applied with non-exertional impairments such as depression. 20 CFR 404, Subpart P, Appendix 2, Section 200.00. Using the Medical-Vocational guidelines as a framework for making this decision and after giving full consideration to the Petitioner's mental and physical impairments, the Administrative Law Judge finds that the Petitioner could perform light work and that the Petitioner does not meet the definition of disabled under the SDA program.

### **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds Petitioner not disabled for purposes of the SDA benefit program. The Petitioner could perform light work and that the Petitioner does not meet the definition of disabled under the SDA program.

Accordingly, the Department's determination is **AFFIRMED**.
