### HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on [REDACTED], from Detroit, Michigan. The Petitioner was represented by Petitioner. The Department of Health and Human Services (Department) was represented by [REDACTED], Hearings Facilitator.

### ISSUE

Did the Department properly close the Petitioner's Food Assistance Program (FAP) and Medical Assistance (MA) benefits?

### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED], the Department sent the Petitioner a Redetermination Form due [REDACTED].
2. On [REDACTED], the Department sent the Petitioner a Notice of Missed Interview.
3. On [REDACTED] the Department sent the Petitioner a New Hire Client Notice with a due date of [REDACTED].

4. On [REDACTED], the Department sent the Petitioner a Health Care Coverage Determination Notice (HCCDN) informing the Petitioner that she was not eligible for MA benefits.
5. On [REDACTED], Petitioner requested a hearing to protest the closure of her FAP and MA benefits.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, the Department began the process of redetermination. The Department sent the Petitioner a Redetermination Form due [REDACTED]; and the Petitioner failed to return a completed Redetermination Form.

On [REDACTED], the Department sent the Petitioner a Notice of Missed Interview.

On [REDACTED], the Department sent the Petitioner a New Hire Client Notice. The Petitioner failed to return the New Hire Client Notice.

The undersigned ALJ finds that the Petitioner had a number of opportunities to comply with the Department's requests for information. The Petitioner responded to none of the requests for information, and the Department closed the Petitioner's FAP and MA benefits for failure to provide requested verifications. (BAM 130, 1/1/2017).

The Petitioner is encouraged to reapply for both FAP and MA benefits and to do what is necessary to comply with the requests of the Department.

**DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed the Petitioner's FAP and MA benefits.

Accordingly, the Department's decision is **AFFIRMED**.
