### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on March 29, 2017, from Lansing, Michigan. Petitioner was represented by his spouse [REDACTED]. The Department was represented by Assistance Payment Worker [REDACTED] and Assistance Payment Supervisor [REDACTED].

### **ISSUE**

Did the Department properly deny Petitioner's October 13, 2016 Medical Assistance (MA) application?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On October 13, 2016, Petitioner submitted an application for Medical Assistance (MA).
2. On December 15, 2016, Petitioner was sent a Health Care Coverage Determination Notice (DHS-1606) which stated he was not eligible due to excess assets.
3. On February 21, 2017, Petitioner's spouse, [REDACTED] submitted a hearing request.
4. On February 22, 2017, the Department reinstated Petitioner's case back to October 13, 2016 and requested asset information.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

The Department did not submit any evidence of Petitioner's assets or their value. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it denied Petitioner's October 13, 2016 Medical Assistance (MA) application.


### **DECISION AND ORDER**
