## HEARING DECISION FOR INTENTIONAL PROGRAM VIOLATION

Upon the request for a hearing by the Department of Health and Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16, 42 CFR 431.230(b), and 45 CFR 235.110, and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on March 7, 2018, from Detroit, Michigan. The Department was represented by **Exercise**, Regulation Agent of the Office of Inspector General (OIG).

Respondent did not appear at the hearing; and it was held in Respondent's absence pursuant to 7 CFR 273.16(e), Mich Admin Code R 400.3130(5), or Mich Admin Code R 400.3178(5).

## **ISSUES**

- 1. Did Respondent receive an overissuance (OI) of Food Assistance Program (FAP) benefits that the Department is entitled to recoup?
- 2. Did the Department establish, by clear and convincing evidence, that Respondent committed an Intentional Program Violation (IPV)?
- 3. Should Respondent be disqualified from receiving FAP benefits for ten years?

# FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The Department's OIG filed a hearing request on September 8, 2017 to establish an OI of benefits received by Respondent as a result of Respondent having received concurrent program benefits and, as such, allegedly committed an IPV.
- 2. The OIG has requested that Respondent be disqualified from receiving program benefits.
- 3. Respondent was a recipient of FAP benefits issued by the Department.
- 4. Respondent was aware of the responsibility to report changes in his residence to the Department.
- 5. Respondent had no apparent physical or mental impairment that would limit the understanding or ability to fulfill this requirement.
- 6. The OIG indicates that the time period they are considering the fraud period is November 1, 2016 through June 30, 2017 (fraud period).
- 7. During the alleged fraud period, Respondent was issued **Example** in FAP benefits from the State of Michigan.
- 8. During the alleged fraud period, Respondent was issued FAP benefits from the State of **Example**.
- 9. This was Respondent's first alleged IPV.
- 10. A notice of hearing was mailed to Respondent at the last known address and was returned by the United States Postal Service as undeliverable.

# CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), and Department of Health and Human Services Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

Effective October 1, 2014, the Department's OIG requests IPV hearings for the following cases:

- FAP trafficking OIs that are not forwarded to the prosecutor.
- Prosecution of welfare fraud or FAP trafficking is declined by the prosecutor for a reason other than lack of evidence, and
  - The total amount for the FIP, SDA, CDC, MA and FAP programs combined is \$500.00 or more, or
  - the total amount is less than \$500.00, and
    - the group has a previous IPV, or
    - > the alleged IPV involves FAP trafficking, or
    - the alleged fraud involves concurrent receipt of assistance (see BEM 222), or
    - the alleged fraud is committed by a state/government employee.

BAM 720 (October 2016), pp. 12-13.

## Intentional Program Violation

Suspected IPV means an OI exists for which all three of the following conditions exist:

- The client intentionally failed to report information **or** intentionally gave incomplete or inaccurate information needed to make a correct benefit determination, and
- The client was clearly and correctly instructed regarding his or her reporting responsibilities, and
- The client has no apparent physical or mental impairment that limits his or her understanding or ability to fulfill reporting responsibilities.

BAM 700 (January 2016), p. 6; BAM 720, p. 1.

An IPV requires that the Department establish by clear and convincing evidence that the client has intentionally withheld or misrepresented information for the purpose of establishing, maintaining, increasing or preventing reduction of program benefits or eligibility. BAM 720, p. 1 (emphasis in original); see also 7 CFR 273(e)(6). Clear and

convincing evidence is evidence sufficient to result in a clear and firm belief that the proposition is true. See M Civ JI 8.01.

In this case, the Department alleges that Respondent committed an IPV of her FAP benefits because she received Michigan-issued FAP benefits at the same time she was issued FAP benefits in **more**. Under Department policy, a person cannot receive FAP benefits in more than one state for any month. BEM 222 (March 2016), p. 2. Additionally, the Department alleges that Respondent committed an IPV of her FAP benefits because she failed to notify the Department that she no longer resided in Michigan but continued to receive and use Michigan-issued FAP benefits while out of state. To be eligible for FAP benefits issued by the Department, an individual must be a Michigan resident. BEM 220 (July 2014), p. 1. For FAP purposes, a person is considered a resident while living in Michigan for purpose other than a vacation, even if he has no intent to remain in the State permanently or indefinitely. BEM 220, p. 1. A client who resides outside the State of Michigan. BEM 212 (July 2014), p. 3.

In support of its contention that Respondent committed an IPV, the Department presented an application submitted by Respondent on April 4, 2016, in which she acknowledged that she received the Information Booklet advising of "Things You Must Do" (which explained reporting change circumstances, including residency). The Department also presented a redetermination submitted by Respondent on March 23, 2017. In the redetermination, Respondent indicated there was no change in her address.

The Department presented documentation from the State of which revealed that Respondent received FAP benefits in march, May and June 2017. The Department further presented a benefit issuance summary relating to Respondent's Michigan issued FAP benefits which indicated that Respondent received Michigan issued FAP benefits during those months.

Additionally, the Department provided Respondent's usage history which demonstrated that Respondent used her Michigan issued FAP benefits exclusively in beginning in November 2016 and continuing throughout the fraud period. The Department also presented a Work Number report which showed Respondent began working for an employer in the on November 18, 2016.

The evidence presented establishes that in March, May and June 2017, Respondent received Michigan-issued FAP benefits, and during the same period, received food assistance benefits issued by the State of **Example**. Thus, the Department established by clear and convincing evidence that Respondent committed an IPV of FAP benefits based on concurrent receipt of benefits.

#### **Disqualification**

A client who is found to have committed an IPV by a court or hearing decision is disqualified from receiving program benefits. BAM 720, p. 15. Clients are disqualified for ten years for a FAP IPV involving concurrent receipt of benefits where the client made fraudulent statement regarding identity or residency, and, for all other IPV cases involving FAP, for standard disqualification periods of one year for the first IPV, two years for the second IPV, and lifetime for the third IPV. BAM 720, p. 16. A disqualified recipient remains a member of an active group as long as he/she lives with them, and other eligible group members may continue to receive benefits. BAM 720, p. 16.

As discussed above, the Department has established by clear and convincing evidence that Respondent committed an IPV through concurrent receipt food assistance benefits from two states at the same time. In order to apply the ten-year disqualification for concurrent receipt of benefits, the Department must establish that the client made fraudulent statements regarding identity or residency. BAM 720, p. 16. In this case, the Department presented a redetermination that was completed by Respondent on March 23, 2017. Respondent indicated that she was still residing in Michigan. Respondent was clearly living in the State of during that period and collected food assistance in during that month. Accordingly, Respondent is subject to a ten-year disqualification.

#### <u>Overissuance</u>

When a client group receives more benefits than they are entitled to receive, the Department must attempt to recoup the OI. BAM 700, p. 1. At the hearing, the Department established that the State of Michigan issued a total of **management** in FAP benefits to Respondent during the fraud period. The Department alleges that Respondent was eligible for **m** in FAP benefits during this period.

In support of its contention that Respondent was overissued FAP benefits, the Department presented Respondent's FAP transaction history showing that she used her FAP benefits issued by the State of Michigan exclusively in **Excert** from November 2016 and continuing throughout the fraud period. Additionally, the Department presented a Work Number report showing Respondent had an address and employment in **Excert** beginning November 18, 2016. The Department provided sufficient evidence to establish Respondent was not residing in Michigan.

The Department alleged that due to Respondent's relocation in November 2016, she was not entitled to benefits as of November 1, 2016. The "10-10-12 Rule" is the unofficial name for the Department policies generally requiring at least 32 days between the date of a circumstance change and the first month that an OI can be established when based on the circumstance change. BAM 105 (October 2016), p. 11, BEM 220, pp. 7 and 12. The rule is applicable to the present case. Additionally, as stated above, an individual must reside out of the state for 30 days before they become ineligible for benefits. Thus, the Department erred by starting the alleged OI period in November 2016 and is not entitled

to recoup the **Markov** in FAP benefits issued to Respondent that month. Accordingly, it is found that the Department has established it is entitled to recoup the **Markov** in FAP benefits it issued to Respondent during the overissuance period from December 2016 through June 2017.

## **DECISION AND ORDER**

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, concludes that:

- 1. The Department has established by clear and convincing evidence that Respondent committed an IPV.
- 2. Respondent did receive an OI of program FAP benefits in the amount of

The Department is ORDERED to initiate recoupment procedures for the amount of in accordance with Department policy.

It is FURTHER ORDERED that Respondent is subject to a ten-year disqualification from FAP benefits.
