**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, an in-person hearing was held on April 4, 2018, from Flint, Michigan. Petitioner represented herself and her husband, [REDACTED], testified on her behalf. The Department was represented by [REDACTED], Hearing Facilitator.

**ISSUE**

Did the Department of Health and Human Services (Department) properly determine Petitioner's eligibility for Food Assistance Program (FAP) benefits?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED], the Department received Petitioner's application for State Emergency Relief (SER) assistance. Exhibit A, pp 7-25.
2. Petitioner receives monthly Supplemental Security Income (SSI) in the gross monthly amount of \$[REDACTED] Exhibit A, pp 29-31.
3. [REDACTED], Petitioner's husband, receives monthly Retirement, Survivors, and Disability Insurance (RSDI) in the gross monthly amount of \$[REDACTED] Exhibit A, pp 26-28.
4. On [REDACTED], the Department received Petitioner's completed Mid-Certification Contact Notice (DHS-2240-A) where she reported no changes to her circumstances. Exhibit A, pp 32-34.

5. On [REDACTED], the Department received Petitioner's request for a hearing protesting the amount of her monthly allotment of Food Assistance Program (FAP) benefits. Exhibit A, pp 5-6.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

All earned and unearned income available is countable unless excluded by policy. Earned income means income received from another person or organization or from self-employment for duties that were performed for compensation or profit. Unearned income means all income that is not earned, including but not limited to funds received from the Family Independence Program (FIP), State Disability Assistance (SDA), Child Development and Care (CDC), Medicaid (MA), Social Security Benefits (RSDI/SSI), Veterans Administration (VA), Unemployment Compensation Benefits (UCB), Adult Medical Program (AMA), alimony, and child support payments. The amount counted may be more than the client actually receives because the gross amount is used prior to any deductions. Department of Human Services Bridges Eligibility Manual (BEM) 500 (July 1, 2017).

FAP group composition is established by determining who lives together, the relationship of the people who live together, whether the people living together purchase and prepare food together or separately, and whether the persons reside in an eligible living situation. Department of Human Services Bridges Eligibility Manual (BEM) 212 (January 1, 2017), p 1.

Petitioner is an ongoing FAP recipient as a group of two. Petitioner and her husband are mandatory group members. All of Petitioner's income and all of her husband's income is countable towards their eligibility for FAP benefits unless excluded by policy. Petitioner is eligible for deductions from that income based on countable expenses specifically allowed by policy.

Based on the evidence and testimony available during the hearing, the Department has presented substantial evidence that it had properly determined Petitioner's countable income, which consists of their benefits from the Social Security Administration. Petitioner failed to identify any expense not listed in BEM 554 as countable expenses,

including expenses associated with a prior bankruptcy, that the Department is not already applying towards their eligibility for ongoing FAP benefits. Therefore, the Department has established that it is properly determining Petitioner's eligibility for FAP benefits.

A request for hearing must be in writing and signed by the claimant, petitioner, or authorized representative. Rule 400.904(1). Moreover, the Department of Human Services Bridges Administrative Manual (BAM) 600 (January 1, 2018), p. 6, provides in relevant part as follows:

The client or authorized hearing representative has 90 calendar days from the date of the written notice of case action to request a hearing. The request must be received anywhere in DHS within the 90 days.

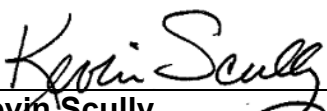
Whether the Department was properly determining Petitioner's countable income in the past is beyond the scope of this hearing decision.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's eligibility for current level of Food Assistance Program (FAP) benefits.

#### **DECISION AND ORDER**

Accordingly, the Department's decision is AFFIRMED.
