HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on August 9, 2018, from Lansing, Michigan. Petitioner was represented by himself. Petitioner's wife, [REDACTED], also appeared and testified. The Department of Health and Human Services (Department) was represented by Adele Sumption, Hearing Facilitator. Katie Kludy, Eligibility Specialist also appeared and testified for the Department. Department Exhibit 1, pp. 1-13 was received and admitted.

ISSUE

Did the Department properly determine Petitioner's Medical Assistance (MA) eligibility and deductible amount?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED], 2018, Petitioner applied for MA.
2. On June 4, 2018, a Health Care Coverage Determination Notice was issued informing Petitioner that he was eligible for MA-G2S with a \$2,318.00 deductible.
3. On June 21, 2018, Petitioner requested hearing disputing the deductible amount.
4. Petitioner's wife receives \$854.00 per month RSDI from Social Security.

5. Petitioner receives \$2,000.00 per month in long term disability income.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.


In this case, Petitioner has unearned income of \$2,854.00 in the form of a social security benefits and long-term disability benefits. After the \$20.00 unearned income exclusion, Petitioner has \$2,834.00 per month net unearned income. The protected income limit is \$516.00. Subtracting \$516.00 from \$2,834.00 results with a deductible of \$2,318.00 per month. This is consistent with the determination made by the Department. Therefore, the Department's determination of G2S coverage with an \$2,318.00 deductible is proper and correct. BEM 541 Petitioner testified that he has significant household expenses and that his high deductible will put him in difficult financial circumstances. It was explained that the undersigned Administrative Law Judge can only review the Department action and determine if it comports with Department policy and there is no authority or jurisdiction to override Department policy based on the individual circumstances of the Petitioner.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's MA eligibility and deductible amount.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
