HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on November 13, 2018, from Lansing, Michigan. Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Sabrina Hopkins, Assistance Payments Supervisor.

ISSUE

Did the Department properly determined Petitioner's eligibility for Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. The Petitioner was a recipient of FAP benefits with a redetermination due in June 2018.
2. On June 30, 2018, Petitioner's FAP case closed.
3. On July [REDACTED] 2018, Petitioner reapplied for FAP benefits.
4. On August [REDACTED] 2018, the Department Caseworker sent Petitioner a Notice of Case Action, DHS 1605, that she was approved for FAP benefits. Department Exhibit 1, pgs. 1-2.

5. On September [REDACTED] 2018, the Department received a hearing request from the Petitioner, contesting the Department's negative action.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, the Department Representative stated that a review of the case showed that a BRIDGES ticket may not have been successfully fixed to give Petitioner benefits that she was entitled to receive in FAP benefits. The BRIDGES ticket is BR#[REDACTED]. After the hearing, the Department Representative submitted written verification that the ticket was resolved, and Petitioner received the additional FAP benefits she was eligible for from the ticket.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined the Petitioner's FAP eligibility.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
