HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on January 2, 2019, from Lansing, Michigan. Petitioner represented himself and his wife, [REDACTED] [REDACTED] appeared as a witness on his behalf. The Department was represented by Benjamin Smith.

ISSUE

Did the Department of Health and Human Services (Department) properly determine Petitioner's eligibility for the Food Assistance Program (FAP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED] 2018, the Department received Petitioner's application for Food Assistance Program (FAP) benefits. Exhibit A, pp 8-16.
2. Petitioner's daughter receives monthly earned income from employment in the gross monthly amount of \$1,848.
3. Petitioner's daughter receives monthly earned income from other employment in the gross monthly amount of \$157.
4. Petitioner receives monthly earned income from employment in the gross monthly amount of \$1,935.

5. On November 8, 2018, the Department notified Petitioner that he was not eligible for the Food Assistance Program (FAP) effective October 26, 2018. Exhibit A, pp 4-7.
6. On November 21, 2018, the Department received Petitioner's request for a hearing. Exhibit A, p 2.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

All earned and unearned income available is countable unless excluded by policy. Earned income means income received from another person or organization or from self-employment for duties for duties that were performed for compensation or profit. Unearned income means all income that is not earned, including but not limited to funds received from the Family Independence Program (FIP), State Disability Assistance (SDA), Child Development and Care (CDC), Medicaid (MA), Social Security Benefits (RSDI/SSI), Veterans Administration (VA), Unemployment Compensation Benefits (UCB), Adult Medical Program (AMA), alimony, and child support payments. The amount counted may be more than the client actually receives because the gross amount is used prior to any deductions. Department of Human Services Bridges Eligibility Manual (BEM) 500 (July 1, 2017).

On [REDACTED], 2018, the Department received Petitioner's application for FAP benefits. Petitioner reported five people in his household, although one of them is not eligible for FAP benefits as an ineligible student. No one in the household was reported to be disabled or more than 64 years-of-age.

The members of Petitioner's household received a combined gross monthly income of \$3,940.27, which was verified from paycheck stubs provided by Petitioner.

The gross monthly income limit to receive FAP benefits is \$2,720 for a group of four, and \$3,188 for a group of five. Department of Health and Human Services Reference Table Manual (RFT) 250 (October 1, 2018), p 1.


Based on the evidence and testimony available during the hearing, Petitioner does not meet the financial criteria for his household to receive FAP benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied Petitioner's application for Food Assistance Program (FAP) benefits.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
