## **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on December 19, 2018, from Lansing, Michigan. The Petitioner was represented by himself. The Department of Health and Human Services (Department) was represented by Julie McLaughlin, Hearing Facilitator and Marlena Huddleston, Eligibility Specialist.

## <u>ISSUE</u>

Did the Department properly determine Petitioner's eligibility for Medical Assistance (MA)?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On 2018, Petitioner applied for MA. Department Exhibit 1, pgs. 1-13.
- 2. On November 1, 2018, the Department Caseworker sent Petitioner a Health Care Coverage Determination Notice, DHS 1606, that effective December 1, 2018 that the Petitioner was not eligible for full MA due to excess income. Department Exhibit 1, pgs. 18-19.
- 3. On November 9, 2018, the Department received a hearing request from the Petitioner, contesting the Department's negative action.

## **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, Petitioner applied for MA on October 18, 2018. He had excess income for full MA. His annual income was \$ but the income limit for full MA was \$16,146.20. Petitioner had excess income for full MA and his application was denied. BAM 220. BEM 110, 125, 126, 135, 163, and 166.

As a result of his excess income for MA AD-Care, Petitioner was determined eligible or a MA Spenddown/Deductible case. Petitioner had Social Security RSDI income of After deductions of a \$20 unearned income general exclusion, \$134 in insurance premiums, and a protected income of Petitioner had a deductible of \$1,426 that he must meet before being eligible for MA. Department Exhibit 1, pg. 15.

#### **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that Petitioner had excess income for MA AD-Care resulting in a Group 2 MA deductible of \$1,426 that he must meet before being eligible for MA.

Accordingly, the Department's decision is **AFFIRMED**.
