HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on February 27, 2019, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Haysem Hosny, Hearing Facilitator.

ISSUE

Did the Department properly calculate Petitioner's eligibility for Food Assistance Program (FAP) benefits based on submitted deductions?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a recipient of FAP benefits.
2. On [REDACTED] [REDACTED] 2018, Petitioner's treating psychologist wrote a letter stating Petitioner was her client and has been in individual psychotherapy for anxiety and depression. Part of her treatment is an emotional support dog. Department Exhibit 2, pg. 2.
3. On January 10, 2019, the Department received a hearing request from Petitioner, contesting the Department's negative action.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, Petitioner is a recipient of FAP benefits. She is entitled to use medical expenses to increase the amount of FAP benefits that she receives. However, Petitioner is required to present receipts that allows the Department Caseworker to determine who provided the service, who received the service, date of service, type of service, and expense of service. The Department was unable to determine the previously listed factors in receipts submitted by Petitioner. Department Exhibit 5, pg. 5. If the Department Caseworker cannot make the determination by the receipt submitted, then the expense cannot be used to increase FAP benefits. BEM 554.

Medical Services

Medical services include the following:

- Service animal (such as a guide dog) or service animal maintenance.


This Administrative Law Judge finds that the Petitioner has an emotional support dog not a service animal. As a result, expenses related to the dog is not an allowable expense for FAP.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined the Petitioner's eligibility for FAP based on the expenses submitted.

Accordingly, the Department's decision is **AFFIRMED**.
