HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on March 13, 2019, from Lansing, Michigan. Petitioner represented herself. The Department was represented by James McHoskey and Janice Parente.

ISSUE

Did the Department of Health and Human Services (Department) properly determine Petitioner's eligibility for Medical Assistance (MA)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an ongoing Medical Assistance (MA) recipient under the Health Michigan Program (HMP).
2. Petitioner became eligible for Medicare on January 1, 2019. Exhibit A, pp 5-7.
3. Petitioner receives monthly Retirement, Survivors, and Disability Insurance (RSDI) in the gross monthly amount of ██████████. Exhibit A, p 6.
4. On January 7, 2019, the Department notified Petitioner that she was not eligible for Medical Assistance (MA) under the Health Michigan Plan (HMP) effective February 1, 2019. Exhibit A, pp 8-9.

5. On January 16, 2019, the Department sent Petitioner a Verification Checklist (DHS-3503) requesting verification of the value of an asset. Exhibit A, p 11.
6. On January 16, 2019, the Department received Petitioner's request for a hearing protesting the closure of her Medical Assistance (MA) benefits under the Healthy Michigan Program (HMP). Exhibit A, p 3.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Petitioner was an ongoing MA recipient under the Healthy Michigan Plan (HMP) that became eligible for Medicare. The HMP is a category of Medicaid available for persons that do not qualify for or are enrolled in Medicare. Department of Health and Human Services Bridges Eligibility Manual (BEM) 137 (January 1, 2019), p 1. Therefore, the Department notified Petitioner that she was no longer eligible for HMP benefits.

Persons may qualify under more than one MA category. Federal law gives them the right to the most beneficial category. The most beneficial category is the one that results in eligibility or the least amount of excess income. Department of Health and Human Services Bridges Eligibility Manual (BEM) 105 (April 1, 2017), p 2.


The HMP is a category of Medicaid with no asset limit. On January 16, 2019, the Department requested that Petitioner provide verification of the value of her countable assets. Petitioner is potentially eligible for other categories of MA other than HMP, but must verify her assets before she can be enrolled in one of those categories of Medicaid.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's Medical Assistance (MA) under the Healthy Michigan Program (HMP).

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.
