HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on May 23, 2019, from Lansing, Michigan. Petitioner was unrepresented. The Department of Health and Human Services (Department) was represented by Sandra Gonzales, PATH Worker.

ISSUE

Did the Department properly deny Petitioner's FAP application?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On ██████████ 2019, Petitioner applied for FAP.
2. On April 17, 2019, the Respondent denied due to excess income.
3. On April 25, 2019, Petitioner filed a hearing request.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference

Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a, and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Applicable policy regarding FAP income and expense budgeting is found primarily at BEM 550, 554, and 556. Corresponding federal regulations are found at 7 CFR 273.2, 273.9, 273.10, 273.11. Income verification is found at BAM 115 and 7 CFR 273.2(f)(1)(i).

In this case, Petitioner initially argued at the administrative hearing that she did not receive the child support income the Department budgeted. However, after reviewing the dates at issue in this hearing, Petitioner did not dispute the income and expenses used the FAP budget pursuant to the March 21, 2019, application. Rather, Petitioner had changes which took place after the denial here. Petitioner has since reapplied.


Petitioner understood that should she dispute any future determinations made by the Department in the future, then she would have a right to a hearing on those determinations, if a timely filing is made. As the facts stand here, the denial of the March 21, 2019, application is supported by credible and substantial evidence and is thus, upheld.

DECISION AND ORDER

Accordingly, the Department's decision is

AFFIRMED.
