HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, an In-Person Hearing was held on June 25, 2019, from Lansing, Michigan. The Petitioner was represented by himself. The Department of Health and Human Services (Department) was represented by Catherine Gernaat, Marci Thompson, and Amanda Fields, Hearing Facilitator also appeared and testified for the Department. Department Exhibit 1, pp. 1-23 was received and admitted.

ISSUE

Did the Department properly determine Petitioner's Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On May 8, 2019, Petitioner requested hearing stating "Because of confusion and lack of follow up on client calls." and checked boxes for FAP and SER.
2. At hearing, Petitioner raised issues with regard to MiCap FAP benefits.
3. Petitioner had a hearing on May 8, 2019, on his eligibility for MiCap FAP benefits and the Department action was affirmed in a Hearing Decision dated May 17, 2019.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The State Emergency Relief (SER) program is established by the Social Welfare Act, MCL 400.1-.119b. The SER program is administered by the Department (formerly known as the Department of Human Services) pursuant to MCL 400.10 and Mich Admin Code, R 400.7001-.7049.


In this case, at hearing Petitioner raised no issues with regard to SER and there was nothing presented to establish that Petitioner applied for SER within 90 days of the request for hearing. At hearing, Petitioner alleged that his request for hearing related to MiCap FAP was never addressed. Petitioner had a hearing on May 8, 2019 and a Hearing Decision was issued on May 17, 2019, affirming the denial of MiCap FAP benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's FAP benefits and SER eligibility.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
