HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on July 17, 2019, from Lansing, Michigan. The Petitioner was represented by himself and his father, [REDACTED]. The Department of Health and Human Services (Department) was represented by Amber Gibson, Hearing Facilitator.

ISSUE

Did the Department properly determine Petitioner's eligibility for State Emergency Relief (SER)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED] [REDACTED] 2019, Petitioner applied for SER for assistance with utilities and eviction. Department Exhibit 1, pgs. 3-8.
2. On May 31, 2019, the Department Caseworker sent Petitioner a denial notice for SER. Department Exhibit 1, pgs. 9-11.
3. On June 5, 2019, the Department received a hearing request from Petitioner, contesting the Department's negative action.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services

Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State Emergency Relief (SER) program is established by the Social Welfare Act, MCL 400.1-.119b. The SER program is administered by the Department (formerly known as the Department of Human Services) pursuant to MCL 400.10 and Mich Admin Code, R 400.7001-.7049.

In this case, the Department conceded at the hearing that due to Department error that they had miscounted Petitioner's assets on June 19, 2019. Department Exhibit 1, pg. 12. Because SER is only good for 30 days, Petitioner was advised to reapply for SER to give her the full time 30 days to pay the copay instead of the four days of the old application. Petitioner has not reapplied for SER. ERM 103.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that Petitioner should reapply due to Department error to give her the full 30 days to meet her SER copay.

Accordingly, the Department's decision is **AFFIRMED**.
