You requested a rehearing on that matter. Your rehearing request is currently pending before ALJ **Mathematical Between December 12, 2018**.

A review of the MAHS records for docket no. 18-011598 shows that, although the hearing was initially scheduled for December 10, 2018 and you timely arrived at the local Department office for the hearing, after your arrival the Department advised MAHS that it could not proceed with the hearing because you had a "zero-tolerance" status with the local office and were prohibited from entering the office. MAHS has no authority with respect to the Department's decision to issue a zero-tolerance letter. MAHS's authority is limited to addressing Department actions in terminating benefits, reducing benefits, or failing to process applications or changes affecting benefits. See Bridges Administrative Manual (BAM) 600 (October 2018), p. 5; Mich Admin Code, R 792.11002. However, to preserve your right to a hearing, MAHS is rescheduling the hearing to allow you to participate in the hearing from your home via telephone. You will receive written notice of the time and date for the new hearing. You should let MAHS know if your telephone number on the hearing notice needs to be changed. On the hearing date, MAHS will initiate the call to you, but you should call MAHS within 30 minutes of the scheduled hearing time if you have not received a call.

MAHS requests that you cease any further direct contact with any ALJs, either by mail or email. If you have concerns regarding the manner that you are treated by Department personnel, you may contact the Department's complaint line at (517) 373-0707.
