**ORDER DENYING ADJOURNMENT REQUEST  
AND ORDER DENYING REQUEST TO VACATE**

On July 9, 2019, the Michigan Office of Administrative Hearings and Rules (MOAHR) received a fax from Petitioner [REDACTED] referencing docket no. 19-003399 and asking for "an adjournment of my case that is scheduled for July 11, 2019" because anticipated legal representation would not be available to her and she needed additional time to prepare for her hearing. The undersigned has reviewed Petitioner's request.

The MOAHR files do not show any hearing scheduled for Petitioner on July 11, 2019. A review of the MOAHR records show that, in response to Petitioner's request for hearing to dispute the actions taken by the Department of Health and Human Services (Department), MOAHR scheduled a hearing under MOAHR docket no. 19-003399 on May 2, 2019 at 9:30 a.m. Petitioner did not appear for that hearing. On May 6, 2019, an Order of Dismissal was issued, dismissing Petitioner's hearing request due to her failure to appear for the scheduled hearing.

Because the hearing date for docket no. 19-003399 has passed and an Order of Dismissal was issued, Petitioner has failed to establish grounds for her adjournment request. Moreover, her request fails to show good cause for vacating the Order of Dismissal.

**NOW, THEREFORE, IT IS ORDERED** that the request to adjourn or to vacate the Order of Dismissal is **DENIED**.
