### **HEARING DECISION FOR INTENTIONAL PROGRAM VIOLATION**

Upon the request for a hearing by the Department of Health and Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16, 42 CFR 431.230(b), and 45 CFR 235.110, and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on August 19, 2019, from Detroit, Michigan. The Department was represented by Adriane Laugavitz, Regulation Agent of the Office of Inspector General (OIG). Respondent did not appear at the hearing. The hearing was held in Respondent's absence pursuant to 7 CFR 273.16(e), Mich Admin Code R 400.3130(5), or Mich Admin Code R 400.3178(5). During the hearing, an 88-page packet of documents was offered and admitted into evidence as Exhibit A, pp. 1-88.

### **ISSUES**

1. Did Respondent receive an overissuance (OI) of Food Assistance Program (FAP) benefits that the Department is entitled to recoup?
2. Did the Department establish, by clear and convincing evidence, that Respondent committed an Intentional Program Violation (IPV) with respect to FAP?
3. Should Respondent be disqualified from receiving FAP benefits?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On November 19, 2015, Respondent submitted to the Department an application for FAP benefits. Exhibit A, pp. 10-38.

2. Respondent signed the application. By signing the application, Respondent certified that he received, reviewed, and understood the information contained within the DHHS publication titled "Things You Must Do." Exhibit A, p. 20.
3. "Things You Must Do" advised Respondent that he was required to report any changes, including a change in address or moving out of the State of Michigan and changes to income, within 10 days of the change and that an intentional failure to do so violated the law and if proven, would result in criminal and/or civil penalties, including potential disqualification from the program. Exhibit A, pp. 21-22.
4. Based on the information Respondent provided in the application, the Department approved Respondent for FAP benefits. Exhibit A, pp. 87-88.
5. On November 30, 2015, Respondent began working for [REDACTED] in Indiana. He provided to [REDACTED] an employee address in Indiana. On January 16, 2016, Respondent began working for [REDACTED] in Indiana, again providing an Indiana address. He continued to be employed in Indiana through February 2016. Exhibit A, pp. 39-48.
6. Respondent never reported either his new income or his move to Indiana to the Department.
7. On June 15, 2017, Respondent submitted to the Department an application for FAP benefits. Exhibit A, pp. 49-79.
8. Respondent signed the application. By signing the application, Respondent certified that he received, reviewed, and understood the information contained within the DHHS publication titled "Things You Must Do." Exhibit A, pp. 60-61.
9. "Things You Must Do" advised Respondent that he was required to report any changes, including a change in address or moving out of the State of Michigan and changes to income, within 10 days of the change and that an intentional failure to do so violated the law and if proven, would result in criminal and/or civil penalties, including potential disqualification from the program. Exhibit A, pp. 61-62.
10. Based on the information Respondent provided in the application, the Department approved Respondent for FAP benefits. Exhibit A, pp. 87-88.
11. Starting September 4, 2017, Respondent's FAP benefits were redeemed exclusively in Indiana through March 21, 2018. From March 22, 2018 through at least June 5, 2018, Respondent's FAP benefits were redeemed exclusively in Georgia. During that entire time period, Respondent did not use his FAP benefits in Michigan a single time. Exhibit A, pp. 80-86.
12. On September 29, 2017, Respondent began working for [REDACTED] in Indiana. He provided an Indiana address as his home address.

From September 29, 2017 through February 2018, Respondent worked regular hours at People Global. Exhibit A, pp. 41-43.

13. Respondent reported neither the beginning of employment nor the Indiana residency to the Department.
14. On June 12, 2018, Respondent obtained employment with ██████████ in Georgia. He provided a Georgia address to ██████████. Exhibit A, pp. 46-48.
15. Respondent did not report his move to Georgia or new income to the Department.
16. From February 1, 2016 to February 28, 2016, the Department issued Respondent FAP benefits of \$194. From November 1, 2017 through June 30, 2018, the Department issued Respondent FAP benefits of \$1,443. Exhibit A, pp. 1-8; 87-88.
17. Based on Respondent's pattern of exclusive use of Department-issued FAP benefits out of state and his statements to his employers that he lived in Indiana and Georgia, the Department investigated the matter to determine whether Respondent was eligible to receive the benefits. During the course of the investigation, the Department found that Respondent appeared to be ineligible for FAP benefits from the Department from February 1, 2016 to February 28, 2016 and again from November 1, 2017 through June 30, 2018. Exhibit A, pp. 1-8.
18. The Department's OIG filed a hearing request on ██████████, 2019, to establish an overissuance of benefits received by Respondent as a result of Respondent having allegedly committed an IPV by collecting FAP benefits from Michigan after moving out of state and failing to report income. Exhibit A, pp. 1-8.
19. This was Respondent's first alleged IPV.
20. The OIG requested that Respondent be disqualified from receiving FAP benefits for a period of one year.
21. The Department's OIG indicates that the time period it is considering the fraud period is February 1, 2016 through February 28, 2016 and November 1, 2017 through June 30, 2018, (fraud period), during which the Department issued Respondent \$1,637 in FAP benefits. Exhibit A, pp. 1-8, 87-88.
22. A Notice of Hearing was mailed to Respondent at the last known address and was not returned by the United States Postal Services as undeliverable.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Bridges Eligibility Manual (BEM), and Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp Program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a, and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10; the Social Welfare Act, MCL 400.1-.119b; and Mich Admin Code, R 400.3001 to .3015.

The Department's position in this matter is that Respondent's failure to report his new income and move out of state while continuing to receive and use his Department-issued FAP benefits amounted to an Intentional Program Violation (IPV) with respect to FAP.

### **Overissuance**

Only residents of Michigan are eligible to receive benefits from the Department. BEM 220 (January 2016), p. 1; 7 CFR 273.18. When an ineligible client is issued benefits or an eligible client is issued more benefits than the client is entitled, the Department must attempt to recoup the OI. BAM 700 (January 2016), p. 1; 7 CFR 273.18.

In this case, the Department showed by clear and convincing evidence that Respondent was a Indiana resident as of December 2015, at the latest. The Department further showed that Respondent was an Indiana and then Georgia resident from at least September 2017 through June 2018. This conclusion is based on the facts that Respondent obtained a job in Indiana in December 2015 and provided that employer with an Indiana home address. Furthermore, Respondent obtained another job in Indiana in September 2017 and maintained that job through at least February 2018, a time during which Respondent's FAP benefits were redeemed exclusively in Indiana. The exclusive Indiana redemption continued until Respondent obtained a job in Georgia in March 2018, at which point Respondent exclusively redeemed his FAP benefits in Georgia.

Thus, Respondent was no longer a Michigan resident and was ineligible to receive benefits. However, because of Respondent's failure to report his moves and employment, the Department issued Respondent FAP benefits of \$1,637. As Respondent was ineligible to receive those benefits, they are considered an overissuance. In total, the overissuance was \$1,637.

### **Intentional Program Violation**

The Department's policy in effect at the time of Respondent's alleged IPV defined an IPV as an overissuance in which the following three conditions exist: (1) the client intentionally failed to report information or intentionally gave incomplete or inaccurate information needed to make a correct benefit determination; (2) the client was clearly and correctly instructed regarding his or her reporting responsibilities; and (3) the client has no apparent physical or mental impairment that limits his or her understanding or

ability to fulfill his or her reporting responsibilities. BAM 720 (January 2016), p. 1; 7 CFR 273.16(c).

An IPV requires that the Department establish by clear and convincing evidence that the client has intentionally withheld or misrepresented information for the purpose of establishing, maintaining, increasing or preventing reduction of program benefits or eligibility. BAM 720, page 1; see also 7 CFR 273.16(e)(6). Clear and convincing evidence is evidence which is so clear, direct, weighty, and convincing that it enables a firm belief as to the truth of the allegations sought to be established. *In re Martin*, 450 Mich 204, 227; 538 NW2d 399 (1995) (citing *In re Jobes*, 108 NJ 394 (1987)).

Respondent was required to report changes in his group's circumstances, including residency and income changes, to the Department within 10 days of the date of the change. BAM 105 (April 2014), pp. 11-12; 7 CFR 273.12(a)(1)-(2). The Department clearly and correctly instructed Respondent to report changes to the Department within 10 days. Respondent failed to report that he moved to Indiana or obtained new employment despite the fact that he was working in Indiana and using his benefits there exclusively. The Department clearly and correctly instructed Respondent be honest and the consequences for failing to do so.

Respondent's failure to report the change to the Department must be considered an intentional misrepresentation to receive benefits he was not entitled to from Michigan since Respondent knew or should have known that he could only receive FAP benefits from the state that he resided in. Respondent sought to maximize his monthly FAP benefits by withholding from the Department the fact that he was no longer a resident who was entitled to its services. The Department has proven by clear and convincing evidence that Respondent committed an Intentional Program Violation.

### **Disqualification**

A client who is found to have committed an IPV by a court or hearing decision is disqualified from receiving FAP benefits. BAM 720, pp. 15-16; 7 CFR 273.16(b). In general, clients are disqualified for standard disqualification periods of one year for the first IPV, two years for the second IPV, and lifetime for the third IPV. BAM 720, p. 16. A ten-year disqualification is imposed if a client makes a fraudulent statement or representation regarding residence in order to receive concurrent benefits from more than one state. BAM 720, p. 16; BEM 203 (October 2015), p. 1.

Respondent committed an IPV with respect to his FAP benefits case by failing to report his move out of states and failing to report his new income while there. As there is no evidence that Respondent has ever been found to have committed an IPV related to FAP benefits, this is Respondent's first FAP IPV sanction. Therefore, Respondent is subject to a one-year disqualification from receiving FAP benefits.

**DECISION AND ORDER**


The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, concludes that:

1. The Department has established by clear and convincing evidence that Respondent committed an IPV with respect to his FAP benefits.
2. Respondent is subject to a one-year disqualification from receiving FAP benefits.
3. Respondent received an overissuance of FAP benefits in the amount of \$1,637 that the Department is entitled to recoup and/or collect.

IT IS ORDERED that Respondent shall be disqualified from receiving FAP benefits for a period of one year.

IT IS ORDERED that the Department may initiate recoupment and/or collection procedures for the FAP overissuance amount of \$1,637 established in this matter less any amounts already recouped or collected.
