HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on December 5, 2019, from Lansing, Michigan. The Petitioner was represented by Petitioner, [REDACTED]. The Department of Health and Human Services (Department or Respondent) was represented by Hearings Facilitator, Kelly Teed.

Respondent's Exhibit a pages 1-21 were admitted as evidence.

ISSUE

Did the Department properly determine Petitioner's Food Assistance Program (FAP) benefit amount?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner is an FAP benefit recipient.
2. Petitioner receives \$ [REDACTED] and SSI monthly allotment; \$ [REDACTED] in our SDI monthly allotment and \$ [REDACTED] per month in quarterly SSI supplemental payment for a total of \$ [REDACTED] in monthly income.
3. Petitioner does not dispute the income or expenses in her case.
4. On October 23, 2019, the Department sent Petitioner a Notice of Case Action indicating that she was approved for Food Assistance Program benefits for \$119

per month from November 1, 2019 through September 30, 2021. She was approved for \$12 for October 7, 2019 through October 31, 2019.

5. On November 1, 2019, Petitioner filed a request for hearing to contest the FAP benefit determination, indicating that her FAP allotment is too low.
6. Upon review of the case, benefits for November 2019 were calculated and it was determined that Petitioner should receive \$119 and FAP benefits.
7. The Department determined that it made an error for October 2019 when it awarded Petitioner only \$12 and FAP benefits.
8. On November 6, 2019, after fixing the error, a supplement of \$83 was awarded to Petitioner for October 7 through October 31, 2019.
9. On November 13, 2019, the Michigan Office of Administrative Hearings and Rules received a hearing summary and attached documents in support of the Department's case.

CONCLUSIONS OF LAW

The regulations governing the hearing and appeal process for applicants and recipients of public assistance in Michigan are found in the Michigan Administrative Code, MAC R 400.901-400.951. An opportunity for a hearing shall be granted to an applicant who requests a hearing because his or her claim for assistance has been denied. MAC R 400.903(1). Clients have the right to contest a department decision affecting eligibility or benefit levels whenever it is believed that the decision is incorrect. The department will provide an administrative hearing to review the decision and determine the appropriateness of that decision. BAM 600.

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Michigan Office of Administrative Hearings and Rules (MOAHR) may grant a hearing for any of the following:

- Denial of an application and/or supplemental payments.
- Reduction in the amount of program benefits or service.
- Suspension or termination of program benefits or service.
- Restrictions under which benefits, or services are provided.
- Delay of any action beyond standards of promptness.

- For FAP only, the current level of benefits or denial of expedited service. BAM 600 (April 1, 2017), pp 3-4.

The client or AHR has 90 calendar days from the date of the written notice of case action to request a hearing. The request must be received in the local office within the 90 days. BAM 600, page 6

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

Pertinent FAP policy indicates:

Federal regulations at 7 CFR 271; 273 provides standards for the determination of Food Assistance Program budgeting. The Department follows the program reference manual, tables, charts, schedules, table 240-1.

Income means a benefit or payment received by an individual which is measured in money. It includes money an individual owns even if not paid directly such as income paid to a representative. Income remaining after applying the policy in the income related items is called countable. This is the amount used to determine eligibility and benefit levels. Count all income that is not specifically excluded. BEM 500, page 1

Gross income is the amount of income before any deductions such as taxes or garnishments. This may be more than the actual amount an individual receives. BEM 500, pages 4-5

Always calculate income on a calendar month basis to determine eligibility and benefit amounts. Use income from a month specified in this item for the benefit month being considered. Budget the entire amount of earned and unearned countable income. Every case is allowed the standard deduction shown in Reference Tables Manual (RFT) 255. Document income budgeting on either a manually calculated or an automated FAP worksheet. (BEM 550, page 1)

Bridges converts all expenses (except one-time-only expenses the group does not wish to average) to a nonfluctuating monthly amount. The same conversion method is used to determine countable available income in BEM 505.

Use only available, countable income to determine eligibility. The Bridges Eligibility Manual (BEM) 500 series defines countable income. BEM 505 defines available income and income change processing. This item describes income budgeting policy.

In the instant case, petitioner receives \$ [REDACTED] per month in SSI benefits; \$ [REDACTED] per month in RSDI benefits and \$ [REDACTED] per month and quarterly SSI supplemental payment for a total of \$ [REDACTED] and monthly unearned income.

Petitioner was then given the standard deduction \$161 for unearned income.

\$ [REDACTED] (monthly gross income) - \$161 (unearned income standard deduction)
= \$ [REDACTED] (monthly adjusted gross income).

Petitioner pays \$200 per month in rent and was given the full heat and utility standard of \$518 per month. Her total shelter expenses were counted as \$718. \$718 and shelter expenses - \$ [REDACTED] (50% of adjusted gross income) = \$396 in excess shelter expenses.

Adjusted gross income of \$ [REDACTED] - \$396 and excess shelter deduction = \$ [REDACTED] in monthly net income.

\$248 x .30 (net income divisor) = \$75.

The maximum monthly FAP benefit for a one-person group = \$194.

\$194 maximum benefit - \$75 (30% of net income) = \$119 in monthly FAP benefit allotment.


A review of Petitioner's case reveals that the Department budgeted the correct amount of income received by the Petitioner at the time of determination. Petitioner's deductions and shelter allotment are governed by Food Assistance Program policy and cannot be changed by the Department or this Administrative Law Judge. If Petitioner provides the Department with information that Petitioner now receives less monthly earned income, the Department can reassess Petitioner's eligibility for increased Food Assistance Program benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department has established by the necessary competent, material and substantial evidence on the record that it was acting in accordance with Department policy when it determined that Petitioner was eligible for a \$119.00 per month in Food Assistance Program benefits. The Department has established its case by a preponderance of the evidence.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
