## **ORDER AMENDING HEARING DECISION**

Following Petitioner's request for a hearing, a telephone hearing was held on February 6, 2020, from Detroit, Michigan in this matter before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; Mich Admin Code, R 792.11002. Petitioner appeared for the hearing and represented herself. The Department of Health and Human Services (Department) was represented by Leonard Garza, Family Independence Manager.

At the conclusion of the hearing, a Hearing Decision was issued on April 3, 2020. After the Hearing Decision was issued, a typographical error was discovered in the Decision and Order portion of the Hearing Decision. The Hearing Decision is hereby **AMENDED** as follows:

The Decision and Order portion of the April 3, 2020 Hearing Decision is deleted and replaced with the following:

Accordingly, the hearing request with respect to the FIP is **DISMISSED** and the Department's SDA determination is **REVERSED**.

THE DEPARTMENT IS ORDERED TO INITIATE THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE THE ORDER WAS ISSUED:

- 1. Reregister and process Petitioner's **Example 1**, 2019 SDA application to determine if all the other non-medical criteria are satisfied and notify Petitioner of its determination;
- 2. Supplement Petitioner for lost benefits, if any, that Petitioner was entitled to receive if otherwise eligible and qualified; and

3. Review Petitioner's continued eligibility in February 2021.

All other provisions of the Hearing Decision, including the Findings of Fact and Conclusions of Law, remain intact and unaffected by this Order Amending Hearing Decision.
