HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on June 18, 2020, from Lansing, Michigan. Petitioner was represented by Petitioner Cheryl Oliver. The Department of Health and Human Services (Department or Respondent) was represented by Cheryl Dyskstra, Family Independence Specialist.

Respondent's Exhibit A pages 1-36 were admitted as evidence.

ISSUE

Did the Department properly deny Petitioner's application for State Emergency Relief (SER)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On January 31, 2020, the client submitted an application for the State Emergency Relief program for home repairs.
2. The worker updated the case with the current information and a Verification Checklist was generated on February 3, 2020, requesting self-employment income and mobile home ownership.

3. A DHS-431, Self-Employment Income and Expense Statement was also generated on February 3, 2020. Client uploaded a Pay Pal statement, but they were not accepted as her name was not on them.
4. In 2019 the client did submit a Pay Pal statement; however, it did have her name on it, and this is why it was accepted.
5. Client failed to return acceptable verification of self-employment income, so case closure was initiated.
6. The client has since reapplied and submitted the DHS-431. Her case is currently active for FAP, MA, and Medicare Cost Share.
7. The interface between Bridges and SSA will be processed within the next four months. Once completed, the Social Security Administration will reimburse the client for any Part B premiums she has paid.
8. Petitioner did receive the maximum \$194 per month in Food Assistance Program benefits for the months of March, April and May 2020 and her Medical Assistance Program benefits were reinstated to the date of closure. She chose to withdraw her request for a hearing on the State Emergency Relief because she cannot afford to do the work at his time.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

The State Emergency Relief (SER) program is established by the Social Welfare Act, MCL 400.1-.119b. The SER program is administered by the Department (formerly known as the Department of Human Services) pursuant to MCL 400.10 and Mich Admin Code, R 400.7001-.7049.

In this case, the Department has established that Petitioner has received all of the benefits to which she is entitled. She received \$194 per month in FAP benefits for the months of March, April and May 2020. Her Medical Assistance has been continuously open. She did not wish to pursue the SER benefits at this time.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it paid Petitioner the maximum FAP benefits and reopened her Medical Assistance benefits the day of closure.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
